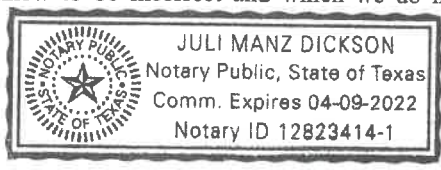
4. To the best of our actual knowledge and belief, since December 18, 1988 there have been no:
