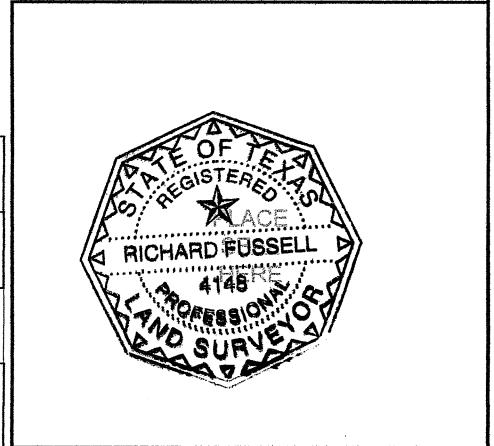

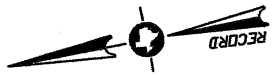

Front of Home 5-26-16



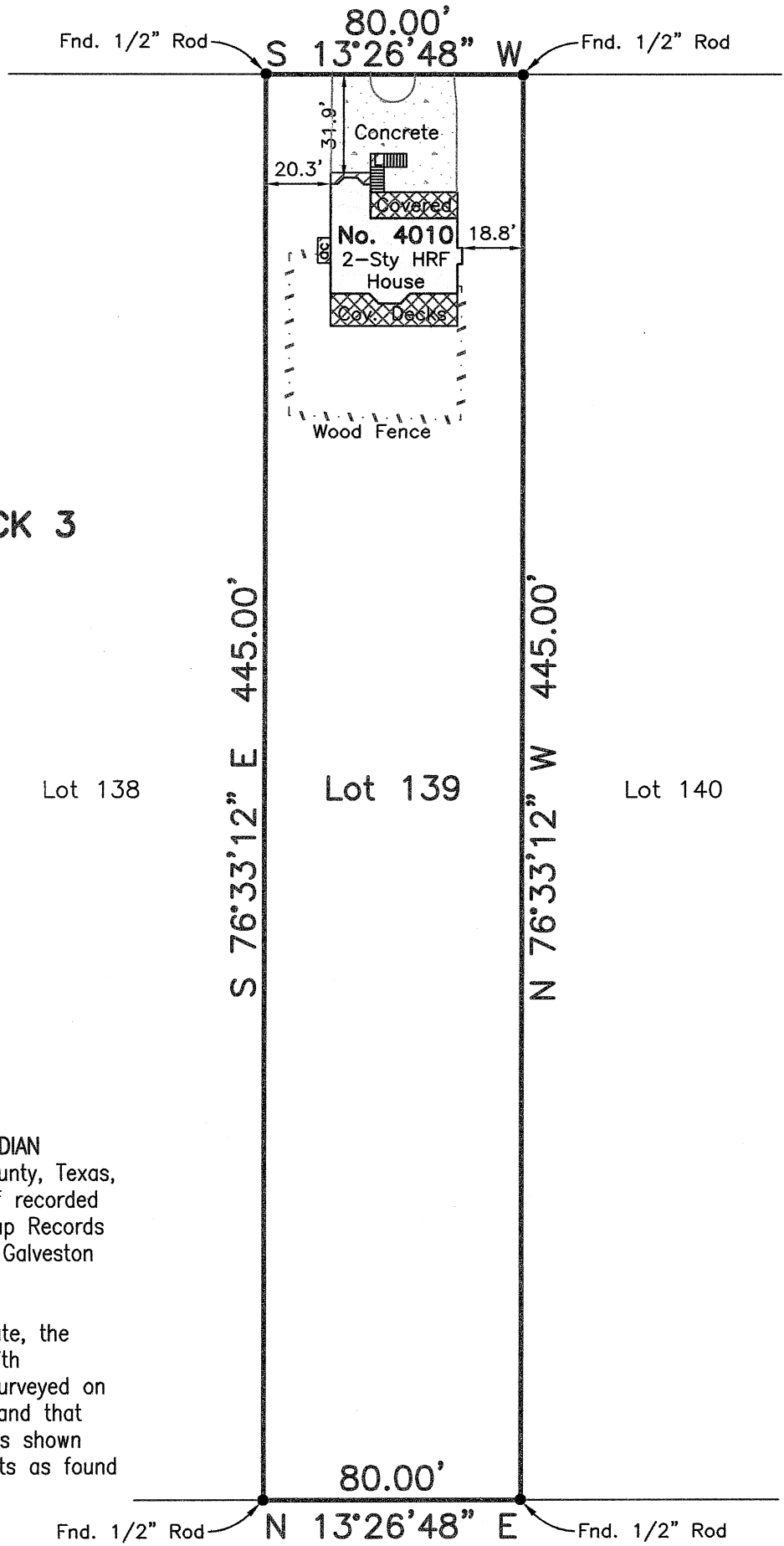
Back of Home 5-26-16
