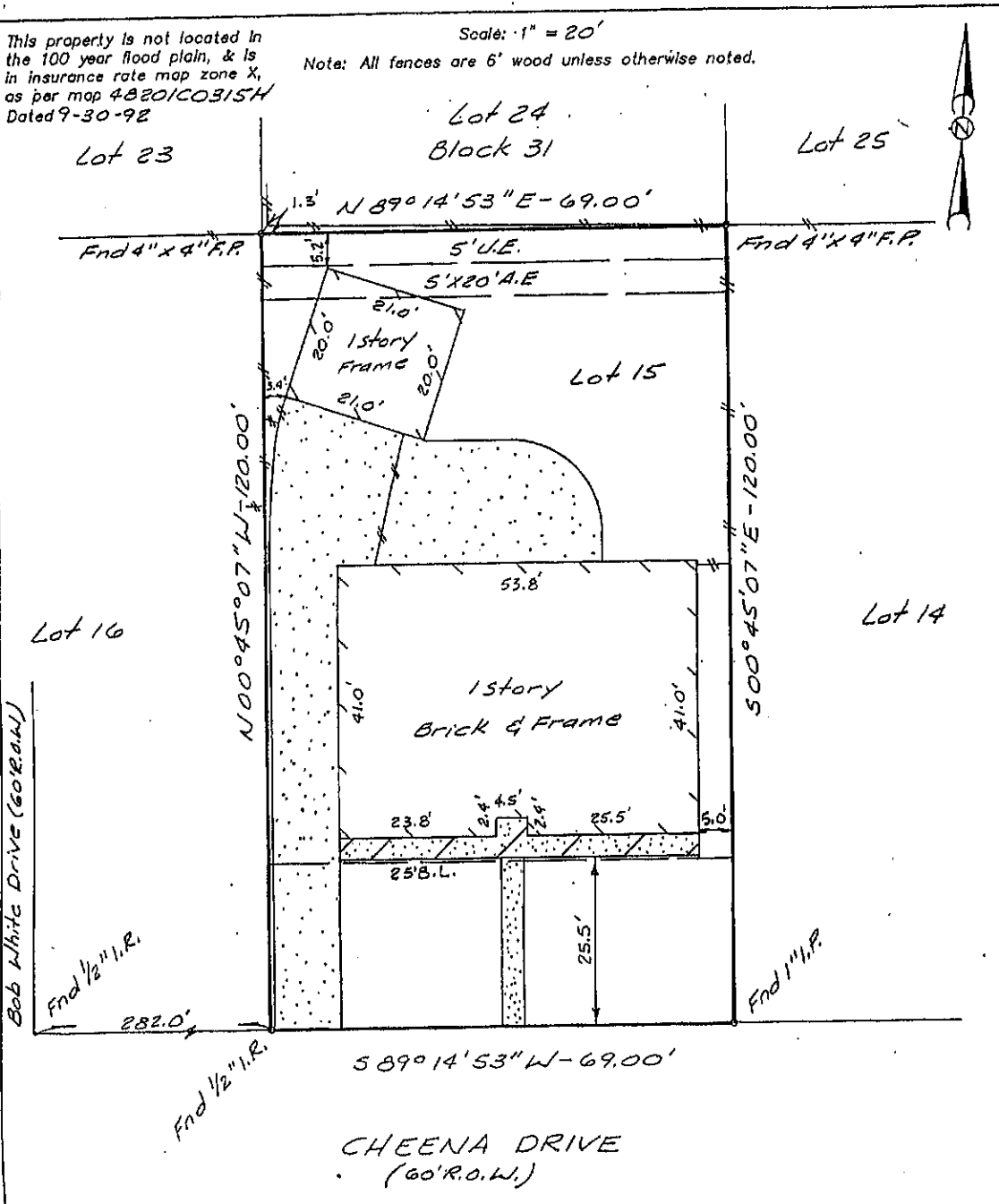


This property is not located in the 100 year flood plain, & is in insurance rate map zone X, as per map 48201C0315H Dated 9-30-92
