We had one water damage event (not related to flooding) in August 2018. The garden tub in the third floor master bathroom was filled during use and stopped up while draining. This water then backed up into the standing shower drain and flooded out onto the entire master bath floor. This water then rained down to the second floor living area and damaged part of the wood floor. This was mitigated immediately and drying processed started within 24 hours and fans dried the ceiling and floors for 3 days. Once dried, the third floor wood trim and carpet pad was replaced. The master shower and bath drains were snaked and cleaned out. The second floor subfloor was saved and the damaged wood was cut out and replaced with an exact match. The entire wood flooring in the house was sanded and stained to match everywhere. The ceiling sheetrock was replaced and the entire ceiling was painted. All light fixtures remained in working condition throughout this event.
