Previous Other Structural Repairs – Previously installed windows discovered to be leaking and rotting studs around windows in 2017. Studs affected were replaced/rebuilt and new windows installed.

Water Damage Not Due to a Flood Event – 1. History of water damage to ceiling in ground floor level due to water overflowing A/C pan, secondary bathroom overflow drain, garbage disposal leak. Each of these conditions and the ceiling have been remedied/repared. 2. During Hurricane Harvey, it was discovered previously improperly installed windows were leaking. All water damage re-mediated immediately, any structural wood rot found replaced with new studs, new windows installed.

*A single blockable main drain may cause a suction entrapment hazard for an individual.

"500-year floodplain" means any area of land that: (A) is identified on the flood insurance rate map as a moderate flood hazard area, which is designated on the map as Zone X (shaded); and (B) has a two-tenths of one percent annual chance of flooding, which is considered to be a moderate risk of flooding.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.
