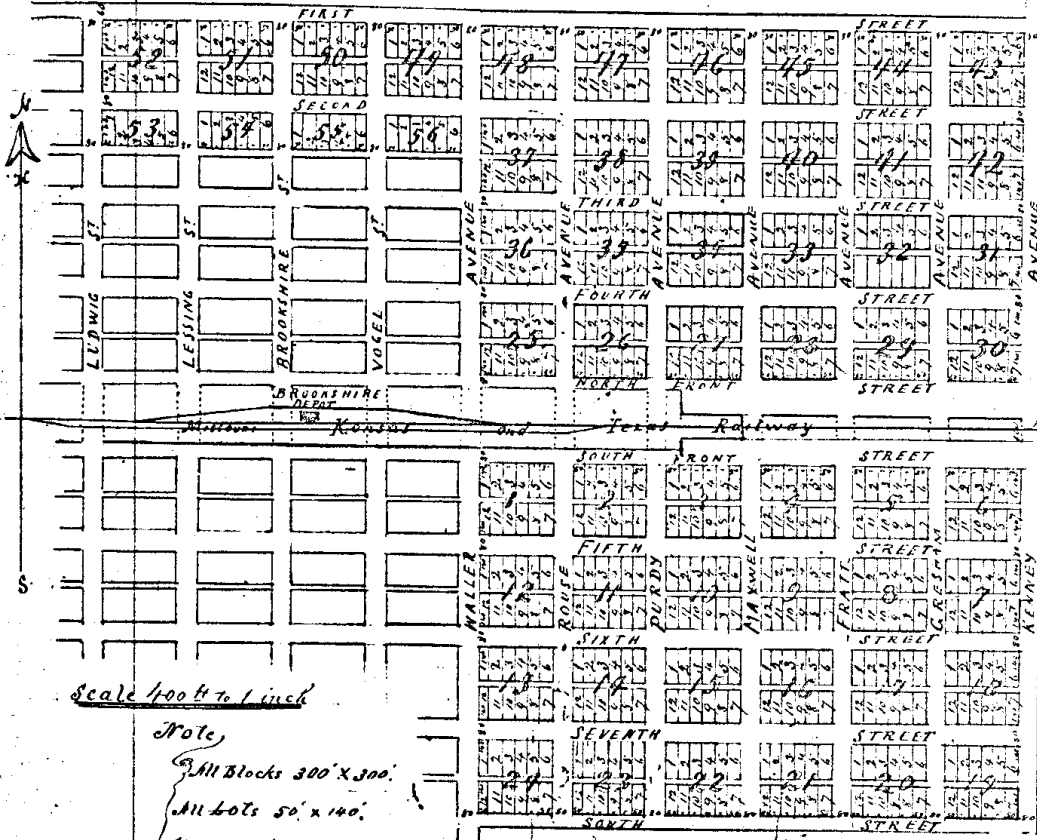


MAP

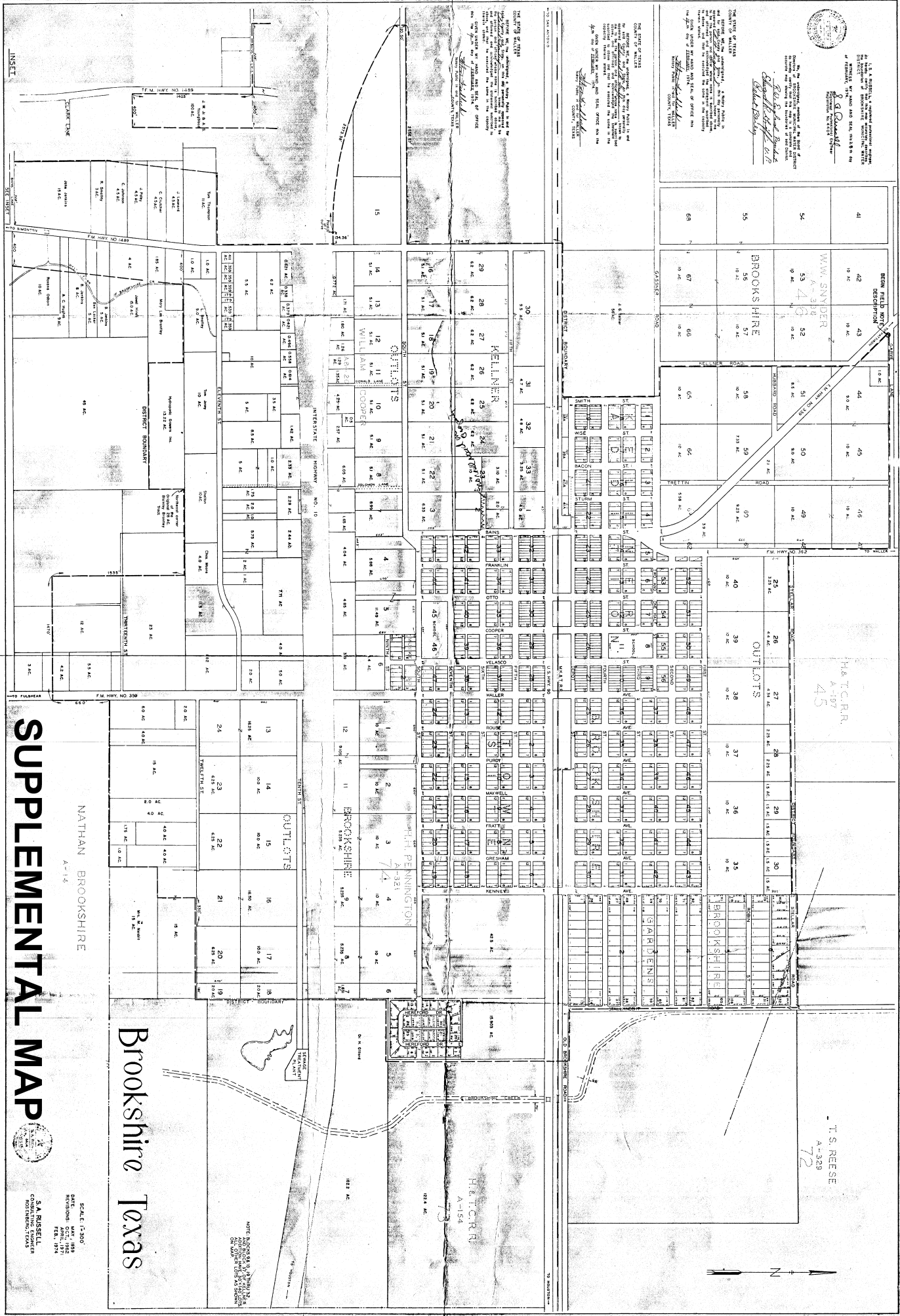
