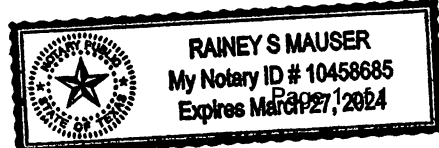

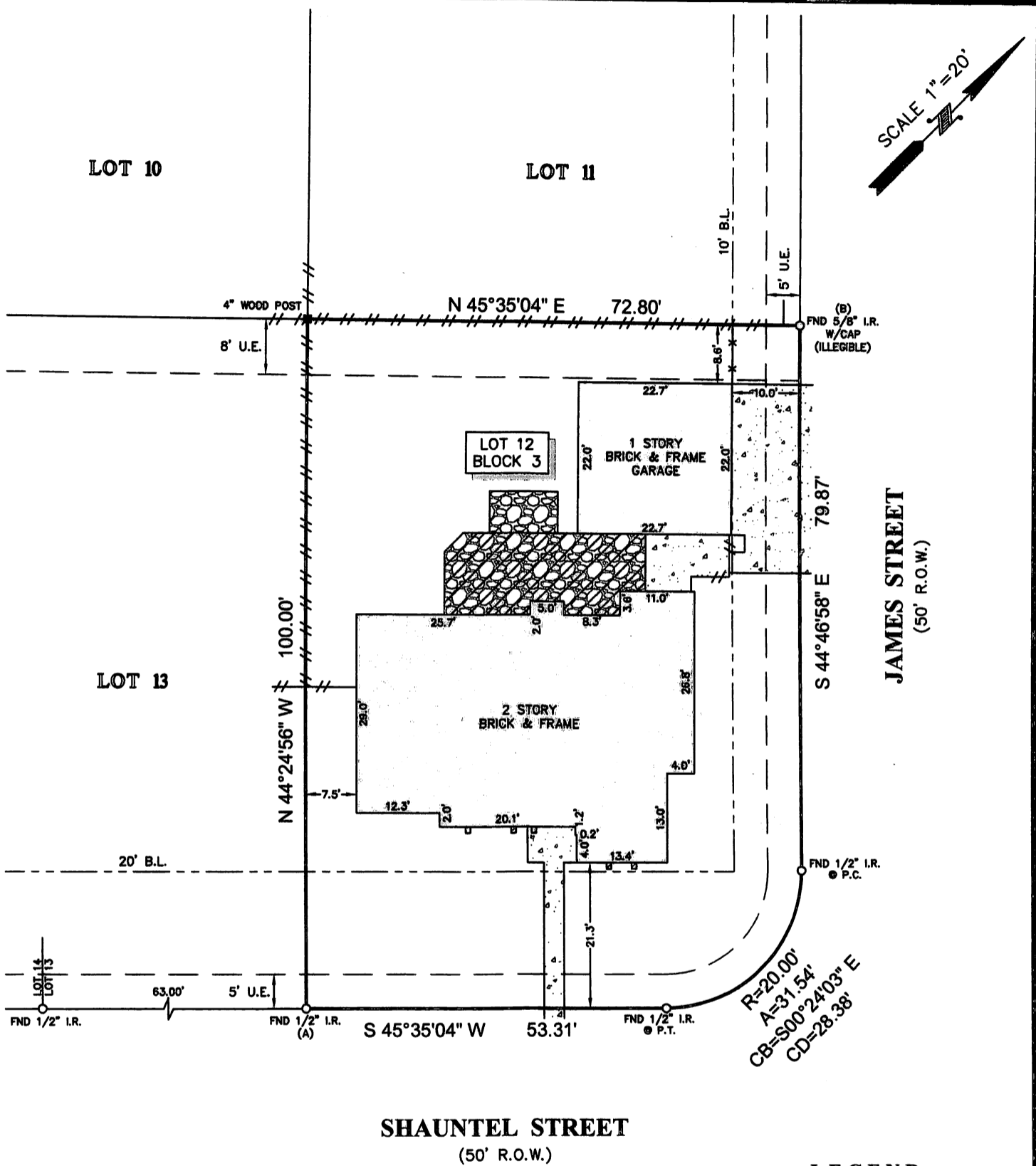
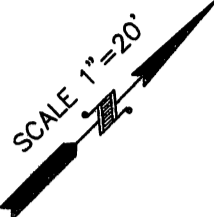

(50' R.O.W.)

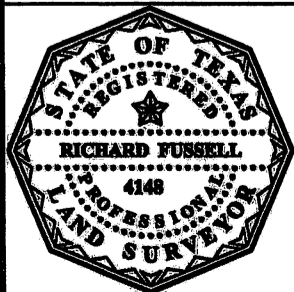
