## RESOLUTION OF SOUTH SHORE HARBOUR COMMUNITY ASSOCIATION, INC. TO AMEND THE BYLAWS RELATING TO QUORUM REQUIREMENTS FOR ELECTIONS ONLY

WHEREAS, South Shore Harbour Community Association, Inc., (hereinafter "Association") is a Texas non-profit corporation;

WHEREAS, Bylaws of Association were duly adopted by the Board of Directors for Association and thereafter amended by that certain Second Amended By-Laws of South Shore Harbour Community Association, Inc., recorded under Clerk's Film Code No. 018-52-1264 of the Real Property Records of Galveston County, Texas ("Amended Bylaws");

WHEREAS, Section 4.06 of the Amended Bylaws provides that the members holding thirty-three percent (33%) of the votes, which may be cast at any membership meeting shall constitute a quorum at such meeting;

WHEREAS, Chapter 209.00593(b) of the Texas Property Code provides that the board of directors of a property owners' association may amend the bylaws of the property owners' association to provide for elections to be held as required by subsection (a) of Chapter 209.00593 of the Texas Property Code;

WHEREAS, Chapter 209.00593(a) and (c) of the Texas Property Code states that: "(a) Notwithstanding any provision in a dedicatory instrument, any board member whose term has expired must be elected by owners who are members of the property owners' association. A board member may be appointed by the board only to fill a vacancy caused by a resignation, death, or disability. A board member appointed to fill a vacant position shall serve the unexpired term of the predecessor board member. . . .(c) The appointment of a board member in violation of this section is void":

WHEREAS, the above law states that new board members cannot be appointed to serve unexpired terms of the predecessor board member and whereas the Association has been unable to conduct an annual meeting to elect board members when quorum cannot be obtained, the Board of Directors of the Association is hereby amending the Amended Bylaws pursuant to the authority of Chapter 209.00593(b) of the Texas Property Code;

WHEREAS, the Board of Directors for Association has determined that Section 4.06 of the Amended Bylaws should be amended to reduce the quorum requirement for the purpose of the election of directors only;

WHEREAS, at a duly constituted regular or special meeting of the Board of Directors, a motion was made and seconded to amend Section 4.06 of the Amended Bylaws to reduce the quorum requirement for the purpose of the election of directors only; and,

NOW, THEREFORE, Section 4.06 is amended to read as follows:

4.06. Quorum of Members. The members holding thirty-three percent (33%) of the votes, which may be cast at any meeting shall constitute a quorum at such meeting. If a quorum is not present or represented, the meeting shall be adjourned without notice other than announcement at the meeting, and immediately reconvened for the sole purpose of election of directors. At the reconvened meeting, a quorum shall be all those members counted as present whether in person or by proxy, absentee ballot, electronic ballot, or any other method of representative or delegate voting. Directors shall be elected by a majority of those votes.

Nothing herein is intended to altar, modify, or amend the By-Laws except as specifically provided hereinabove.
