THE MOLD WAS CAUSED BY A FAN COIL UNIT REPLACEMENT IN THE ORIGINAL HVAC SYSTEM. THE REPAIR MAN FAILED TO CLEAN UP WATER THAT WAS CAUSED FROM THE ORIGINAL FAN COIL REPLACEMENT. THE WATER WAS THROWN INTO THE DUCT BOARD PLENUM. OVER A SERIES OF MONTHS IT DEVELOPED MOLD. THE MITIGATION MEASURES WERE AS FOLLOWS:

- 1) REMOVE PLENUM & REPLACE WITH COMMERCIAL GRADE INSTALLATION OF STAINLESS STEEL PLENUM WITH EXTERNAL INSULATION,
- 2) REPLACED ALL FLEX & DUCT BOARD DUCTS IN THE ATTIC.
- 3) HOSPITAL GRADE SANITIZER WAS APPLIED TO ALL WOOD STRUCTURE IN THE ATTIC,
- 4) REPLACED ALL INSULATION IN ATTIC.
- 5) REDUCED RIDGE VENT ON ROOF.
- 6) INSTALLED PERMANENT HEPA FILTER IN HVAC SYSTEM IN ATTIC & INSTALLED NEW DEHUMIDIFIER.
- 7) CLEANED ALL DUCTWORK ON 2ND FLOOR WITH HOSPITAL GRADE DISINFECTANT.
- 8) HOME WAS INSPECTED BY 3RD PARTY MOLD TESTING AGENT UPON COMPLETION AND ISSUE WAS RESOLVED.
