

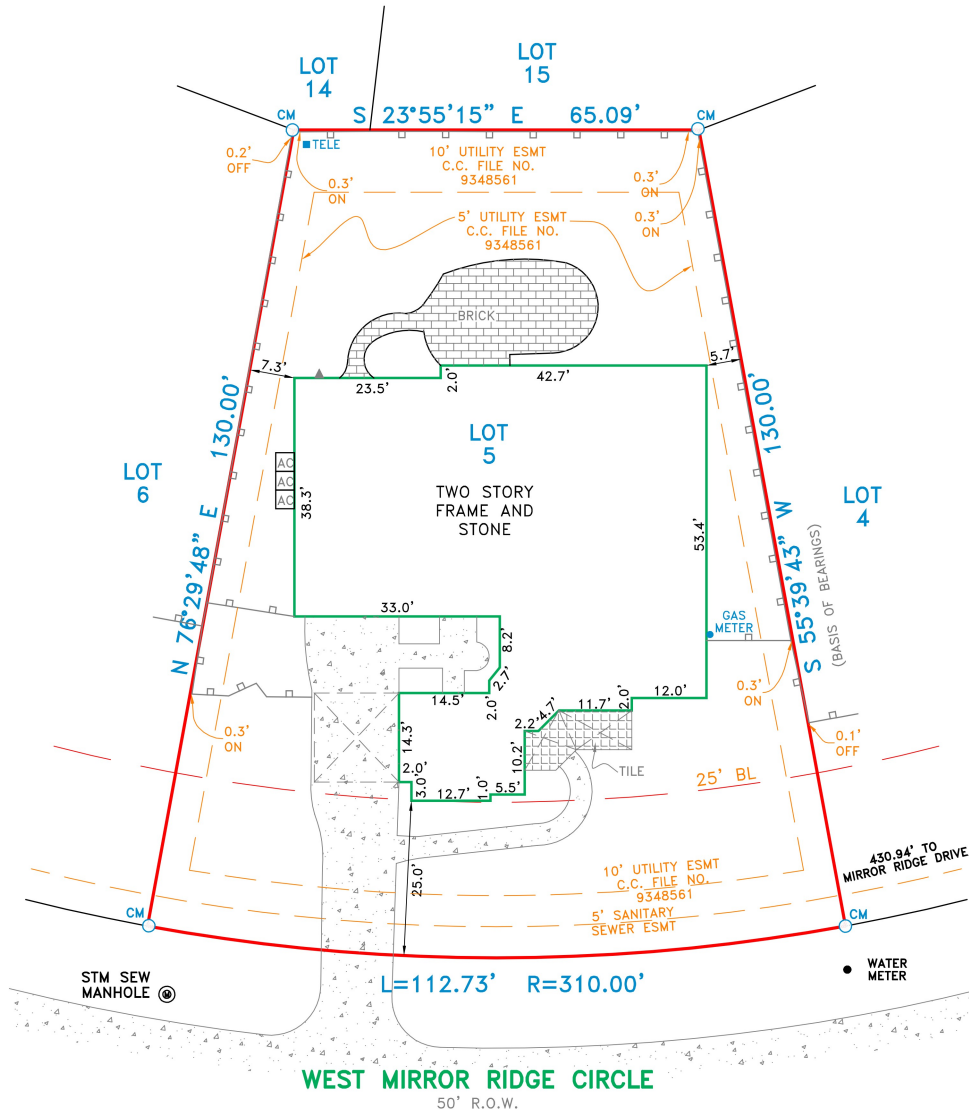
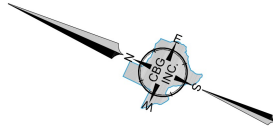
# 71 West Mirror Ridge Circle
