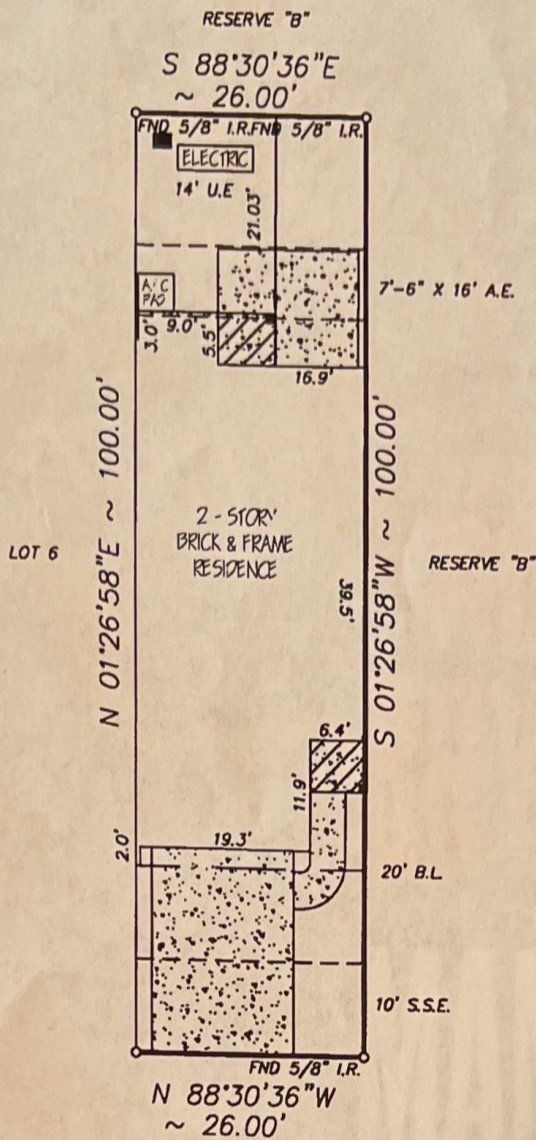




HOUSE IS UNDER 16' IN HEIGHT
