It has been our pleasure to file the articles of incorporation and issue the enclosed certificate of incorporation evidencing the existence of the newly created corporation.

Corporations organized under the Texas Non-Profit Corporation Act do not automatically qualify for an exemption from federal and state taxes. Shortly, the Comptroller of Public Accounts will be contacting the corporation at its registered office for information that will assist the Comptroller in setting up the franchise tax account for the corporation. If you need to contact the Comptroller about franchise taxes or exemption therefrom, you may contact the agency by calling (800) 252-1381, by email to tax.help@cpa.state.tx.us or by writing P. O. Box 13528, Austin, TX 78711-3528. Telephone questions regarding other business taxes, including sales taxes, should be directed to (800) 252-5555. Information on exemption from federal taxes is available from the Internal Revenue Service.

Non-profit corporations do not file annual reports with the Secretary of State, but do file a report not more often than once every four years as requested by the Secretary. It is important for the corporation to continuously maintain a registered agent and office in Texas as this is the address to which the Secretary of State will send a request to file a periodic report. Failure to maintain a registered agent or office in Texas, failure to file a change to the agent or office information, or failure to file a report when requested may result in involuntary dissolution of the corporation. Additionally, a non-profit corporation will file documents with the Secretary of State if the corporation needs to amend one of the provisions in its articles of incorporation.

Article	e 5 – Duration

The period of duration is perpetual.

Article 6- Purpose

The corporation is organized for the following purpose or purposes:

This Association is formed to provide for the Promotion of Community Welfare of the Simmons Lakes Community and to assure maintenance, preservation and architecture control of the property subject to the Covenants, Conditions and Restrictions for Simmons Lakes Subdivision, applicable to certain land located in Colorado County known by official plat designation as Simmons Lakes, a subdivision, (hereinafter referred to as the "Property") described in the plat (hereinafter referred to as the "Plat") known a Simmons Lakes, according to the plat thereof recorded in Slide Number 70 through 73 of the plat records of Colorado County, Texas which Plat is subject to the conditions and restrictions declared and recorded in the Colorado County Official Records at Volume 176, Page 37, and Volume 180, Page 533, and any additional property that may hereinafter be made subject to the Declaration and to promote the health, safety and welfare of the residences within the above-described property and for this purpose, the Association shall have the power and authority to:

- a) Provide and maintain, to the extent deemed appropriate by the Association, the common area, facilities, and services of overall benefit to the Public and the Simmons Lakes members, residents and occupants in general;
- b) Fix, levy, collect and enforce payment by any lawful means, of all charges or assessments pursuant to the terms of the Declaration to pay all expenses, licenses, taxes or governmental charges levied or imposed against the property of the Association and all other expenses incidental to the conduct of the business of the Association. No such assessments shall be effective unless approved by vote of at least two thirds (2/3) of voting members of the Association, indicating their agreement to such assessment;
- Acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in conjunction with the affairs incurred;
- d) Exercise any and all powers, rights and privileges that a non-stock, non-profit corporation organized under the laws of the State of Texas by law may now or hereafter have or exercise.

Exercise all the powers and privileges and perform all the duties and obligations of the Association as set forth in the Declaration applicable to the Property and recorded or to be recorded among the Land Records of Colorado County, Texas and as the same may be amended from time to time therein provided, said Declaration being incorporated herein as if set forth at length and made a part hereof.

Supplemental Provisions/Information

ARTICLE 7 - NO CAPITAL STOCK

This Association is not authorized to issue any capital stock and shall not be operated for profit. The Association does not anticipate distributing dividends, gains or profits to its members. No member shall have any personal liability for the debts or obligations of the Association.

ARTICLE 8 - MEMBERSHIP

Every person or entity who is a record owner of a fee or undivided fee interest in any Lot or Lots forming a part of the Property including contract sellers, shall be a member of the Association; provided that any such person or entity who or which holds such interest merely as security for the performance of an obligation shall not be members. Membership shall be appurtenant to and may not be separated from ownership of the Property, which is subject to assessment, by the Association. Ownership of such Property shall be the sole qualification for membership.

ARTICLE 9 - VOTING RIGHTS

The members shall be all the Owners and shall be entitled to one (1) vote per owner irrespective of the number of lots owned. When more than one (1) person holds an interest in any lot or group of lots, all such persons shall be members. The vote for such lot or group of lots shall be exercised as they, among themselves, determine, but in no event shall more than one (1) vote be cast. Owners shall have the right to assign their voting rights hereunder to tenants or other persons as they may designate by use of a proxy, fully executed and acknowledged.

The members of the Association shall have no preemptive rights, as such members, to acquire any memberships of this Association that may at any time be issued by the Association except as may be specifically provided in these Articles of Incorporation.

ARTICLE 10 - BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board initially consisting of four (4) Directors whose names and addresses are listed in Article 3 herein. Commencing with the first annual meeting of the Association, the Board shall consist of not less than three (3) or more than five (5) Directors. No change in the Number of Directors shall operate to curtail or extend the term of any incumbent Director. The Directors need not be members of the Association.
