During Harvey there was some pooling in the back yard, mostly a result of too much mulch being used along the fence and the placement of back yard gutter drains resulting in impaired drainage of water to the street. This resulted in water seeping into the garage (less than half an inch; no standing water); treated with bleach. Drainage can be improved with french drains. Home never flooded.
