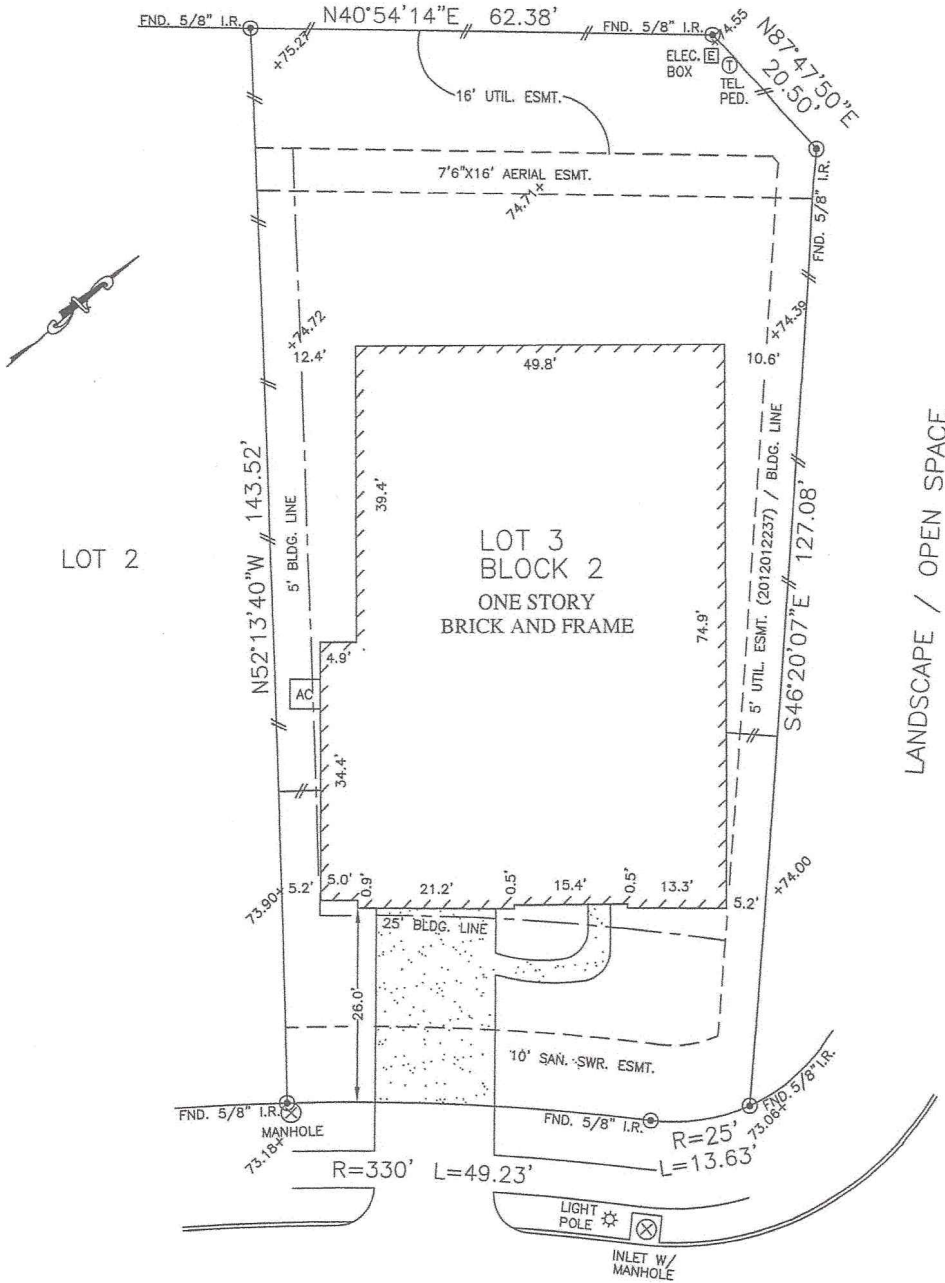

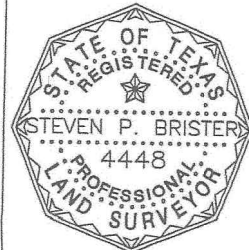


"Title Company" as used herein is the Title Insurance Company whose policy of title insurance is issued in reliance upon the statements contained herein.


Before me, the undersigned notary for the State of Texas, personally appeared Affiant(s) who after by me being sworn, stated:

 - d. conveyances, replattings, easement grants and/or easement dedications (such as a utility line) by any party affecting the Property.


