FIELD NOTE DESCRIPTION OF 30.714 ACRES OF LAND OUT OF THE E. GREENWOOD LEAGUE, ABSTRACT NO. 26, IN BURLESON COUNTY, TEXAS, AND BEING A PORTION OF THOSE CERTAIN (TRACT ONE-46.2 ACRES, TRACT TWO-1.0 ACRES, AND TRACT 3-2.0 ACRE) TRACTS OF LAND CONVEYED TO MAE DELL COWAN IN A DEED AS RECORDED IN VOLUME 799 PAGE 655 OF THE OFFICIAL RECORDS OF BURLESON COUNTY, TEXAS, AND BEING ALL OF THAT CERTAIN (FIRST TRACT-8.00 ACRE) AND A PORTION OF THAT CERTAIN (SECOND TRACT-41.2 ACRE) TRACTS OF LAND CONVEYED TO J.D. COWAN AND MRS. MAEDELL COWAN IN A DEED AS RECORDED IN VOLUME 123 PAGE 344 OF THE DEED RECORDS OF BURLESON COUNTY, TEXAS, AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING FOR REFERENCE at a ½" iron rod found in the southeasterly right-of-way line of Farm to Market Road (FM) 111 being in the northeasterly line of that certain (First Tract-8.00 acre) tract of land conveyed to J.D. Cowan and Mrs. Maedell Cowan in a deed as recorded in Volume 123 Page 344 of the Deed Records of Burleson County, Texas, and being the most northerly corner of those certain (Tract One-46.2 acres, Tract Two 1.0 acre, and Tract 3-2.0 acre) tracts of land conveyed to Mae Dell Cowan in a deed as recorded in Volume 799 Page 655 of the Official Records of Burleson County, Texas, and also being in the southwesterly line of that certain (Tract No. 4-108 acre) tract of land conveyed to Barry Ray Helweg in a deed as recorded in Volume 263 Page 385 of the Deed Records of Burleson County, Texas, and from which a concrete highway monument found bears N 42 deg. 58' 08" E 387.15 feet,

THENCE, leaving the southeasterly right-of-way line of F.M. 111, and with the common line between the Cowan tracts and the Helweg tract, S 46 deg. 59' 02" E 945.46 feet to a ½" iron rod set for the most northerly corner and PLACE OF BEGINNING of the tract herein described,

THENCE, continuing with the common line between the Cowan tracts and the Helweg tract, S 46 deg. 59' 02" E 1438.42 feet, to a ½" iron rod set at the base of a fence corner post, being at the most easterly corner of the Cowan tracts, and being in the northwesterly line of that certain (100 acre) tract of land conveyed to Wayne Eichholz in a deed as recorded in Volume 1044 Page 18 of the Official Records of Burleson County, Texas, being that same (100 acre) tract described in Volume 160 Page 718 of the Deed Records of Burleson County, Texas, and being for the most easterly corner of this tract,

THENCE, with the common line between the Cowan tracts, and the Eicholz tract, S 44 deg. 10' 20" W 935.64 feet, to a 5/8" iron rod found at the base of a fence corner post in the northeasterly right-of-way line of Farm to Market Road (FM) 60 South, being for the most southerly corner of this tract, and from which another 5/8" iron rod found bears S 47 deg. 14' 34" E 4236.42 feet,

THENCE, with the northeasterly right-of-way line of Farm to Market Road (FM) 60 South, being for the southwesterly line of the Cowan tracts, N 46 deg. 31' 00" W 1113.87 feet, to a concrete highway monument found and N 46 deg. 28' 49" W 326.04 feet, to a ½" iron rod set for the most westerly corner of this tract, and from which a ½" iron rod set at the base of a fence corner post in the southeasterly line of those tracts of land conveyed to the St. John's Evangelical Lutheran Church in a deed as recorded in Volume 107 Page 93 of the Deed Records of Burleson County, Texas, bears N 46 deg. 28' 49" W 366.90 feet,

THENCE, leaving the northeasterly right-of-way line of Farm to Market Road (FM) 60 South, and over and across the Cowan tracts, N 44 deg. 16' 37" E 923.73 feet, to the PLACE OF BEGINNING, in all containing 30.714 acres of land.
