

Previous Roof Repairs – Minor roof leaks repaired in 2020 and 2021. Re-sealed all flashing, installed water diverters and repaired fascia boards. No signs of leaking have been detected since.

Water Damage Not Due to a Flood Event – Water intrusion in 2015 "Memorial Day Flood". Water did not drain from backyard around the side of the house quickly enough and the water seeped in along the rear edge. French drains installed in 2020 to fix drainage. Dishwasher leak in 2018. Dishwasher replaced.

Previous treatment for termites or WDI – Termite infestation was eradicated prior to us occupying the home. No signs of further termites since.

Previous termite or WDI damage repaired – Previous termite damage was found while repairing trim along the front windows. No signs of active termites was found. All damaged wood was replaced.


