(FISHING LICENSE IS **NOT** REQUIRED IN FOREST OAKS PARK UNLESS FISHING IN CYPRESS CREEK)

### FLOOD MITIGATION UPDATES

#### Haas Detention Pond

HC 110 and HCFCD have partnered to excavate, enlarge, and improve the current detention pond located behind the Fred Haas dealerships, which will provide additional volume to facilitate drainage and mitigate flooding. SK Law is finalizing the Agreement with HCFCD and construction is expected to begin in early 2021.

#### Enchanted Stream

HC 110 and LEI are currently working with CenterPoint and AT&T to relocate existing utilities along Enchanted Stream, just south of Cypresswood. CenterPoint has provided to LEI a preliminary design plan to relocate the power lines along Seals Gully, at an estimated cost of \$62,570, along with the installation of LED streetlights on each relocated pole at an estimated cost of \$1544. AT&T is working on its design plan. After design plans are approved, relocation may begin in early 2021. After existing utilities have been relocated, detention pond(s) may be constructed to divert some of the flood waters flowing into Senger Gully. It is anticipated that, after the utilities have been relocated, HC 110 may partner with HCFCD on the detention pond projects.

#### NEW DETENTION

NEW DETENTION POND TO BE CONSTRUCTED ON THE EAST SIDE OF I-45.

In late 2019, HC 110 Director Vanessa Sommer and District Engineer John Davis met with Harris County Flood Control District (HCFCD) Deputy Executive Director Matt Zeve to propose that HCFCD purchase available land on the East side of I-45 for the purpose of constructing a regional detention pond. As a result of this meeting, Director Sommer's proposal was included as an Amendment to the Michael Baker Flood Study, and was adopted by the Harris County Commissioner's Court. On December 27, 2020, HCFCD closed on the purchase of 54 acres for the purpose of constructing a new regional detention pond. This new detention pond will have a direct impact and will help mitigate flooding in HC WCID 110, HC WCID 99, Pine Forest MUD, Inverness Forest Improvement District, Timberlane MUD, and HC MUD 249.

#### I-45 at Cypress Creek

TxDOT has advised that its project to rebuild/replace the southbound frontage road at I-45 and Cypress Creek is on schedule for Summer of 2021. TxDOT provided the following status –

- Survey work is complete
- Preliminary Level B subsurface utility engineering is complete, with a final report expected October 19, 2020
- Two of the three Geotech borings are complete. The third bore location will be drilled after verification of a potential utility conflict
- A draft hydraulic analysis drainage report is expected by the end of October
- A preliminary bridge layout is expected by the end of October or early November
- Preliminary horizontal alignment for the southbound frontage road is expected by the end of October
- The hydraulic analysis, preliminary bridge layout, and horizontal alignment are subject to change pending the findings of the utility subsurface utility engineering investigation

# Progress on the T.C. Jester Stormwater Detention Basin

## Construction Zone to be Closed to the Public Until Further Notice

As part of the Harris County Flood Control District's focus on reducing flood risks in the Cypress Creek watershed, crews will begin a preliminary excavation and removal project starting on or about November 18 in connection with the T.C. Jester Stormwater Detention Basin construction project. The eventual goal of the T.C. Jester Stormwater Detention Basin project is to provide an excavated area to take in and temporarily hold excess stormwater during heavy rain events. Excavation & removal (E&R) projects such as this one reduce taxpayer costs and result in a shorter construction process by allowing a contractor to remove a set amount of dirt before major construction commences.

This excavation and removal project will take place ONLY on Flood Control District-owned property WEST of T.C. Jester Boulevard and south of Cypresswood Drive (Project ID: K500-23-00-E001). The entire property west of T.C. Jester Boulevard will be closed to the public for safety reasons for the duration of the E&R, which could be up to three years. The E&R process requires heavy equipment, including dump trucks, excavators and bulldozers, to remove trees, vegetation and soil from the preliminary excavation area. For the safety of the public and construction crews, we urge community members to heed all warning signs and to avoid the entire property. Construction equipment and trucks will access the property from T.C. Jester Boulevard. Motorists are cautioned to be alert to truck traffic when passing near construction access points and along truck routes.

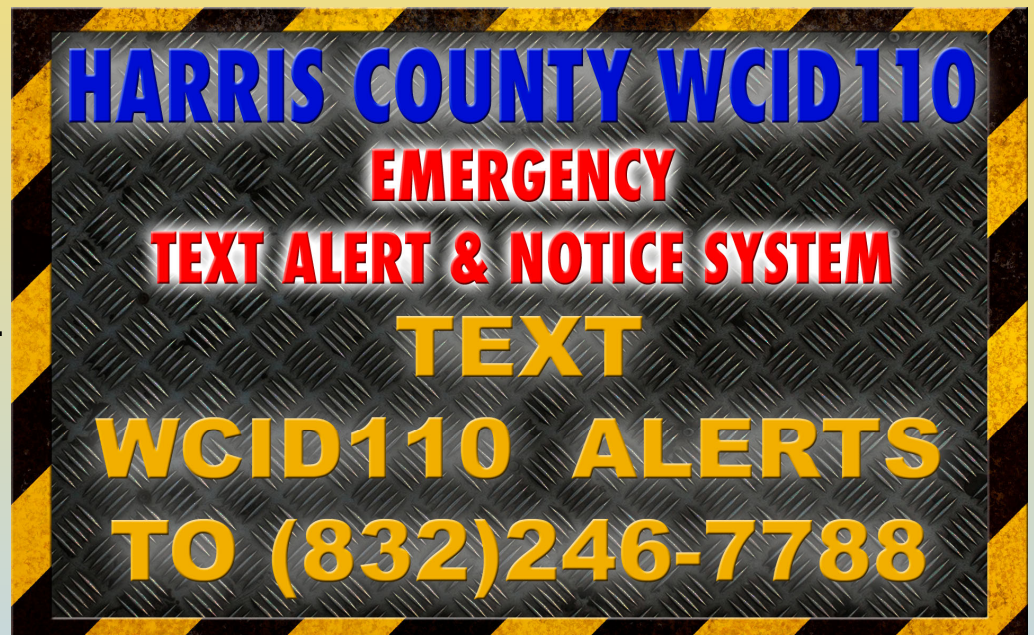
The Flood Control District is aware of trails that exist on the property. There is no existing written agreement for use of this property by any other group or agency. The property was purchased with tax dollars for flood risk reduction purposes. At the appropriate time during preliminary engineering for the basin, there will be opportunities for sponsors who wish to build and maintain trails to share their proposed trail plans with the Flood Control District.

## WATER PLANT #2 GETTING A GENERATOR

WCID110 is currently working on installing a generator at water plant #2. Water plant #2 is located behind Spring High School at Cypresswood Lake. Water plant #2 is the District's 3rd water well. When power is lost on the east side of I-45, water plant #2 drops offline and water is provided to the area from water plant #1 which has 2 wells, NHRWA surface water, and a generator.

Having the additional generator at water plant #2 will increase our ability to ensure service during emergencies like hurricanes and freezing temperatures in the future. WCID110 fared extremely well during Harvey and this last historical freeze, however an additional generator helping to keep water plant #2 online during these emergency events will ensure our capabilities remain very strong for our residents.

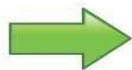

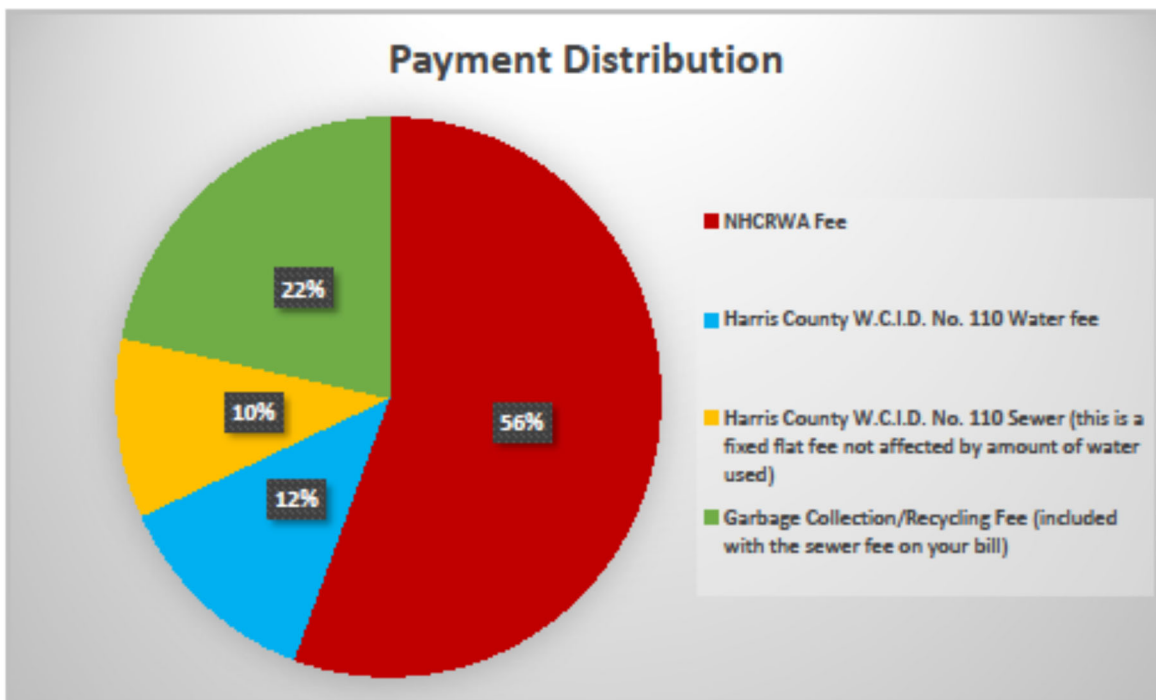

# Where My Water Bill Payments Go

As the cost of water continues to rise, we thought it would be helpful to show *residential only* customers where your payment goes.

If you were to use 10,000 gallons of water, your total bill would be **\$97.10** Of that total:

- **\$54.10** is the fee charged by and paid to the North Harris County Regional Water Authority (NHCRWA). The fee is currently \$5.41 / 1,000 gallons.
- **\$12.00** is the water fee charged by Harris County W.C.I.D. No. 110 (There is a flat fee of \$11.00 / 8,000 gallons used, and a variable fee per thousand gallons is charged over 8,000 gallons of use.)
- **\$10.07** is the flat sewer fee charged by Harris County W.C.I.D. No. 110
- **\$20.93** is the garbage collection / recycling fee paid to Best Trash (this fee is included with the sewer fee on your bill)

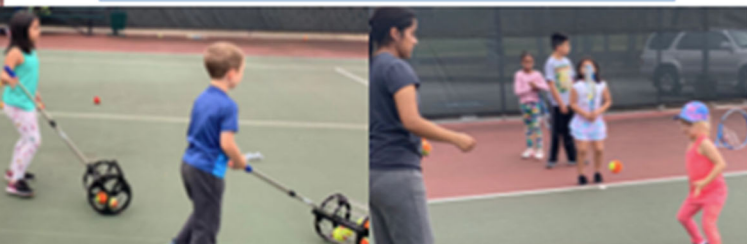

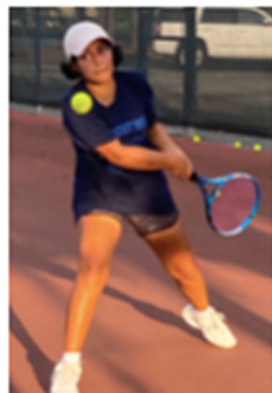
