On January 1st, 2021, there will be a slight increase in Forest Oaks Swim & Racquet Club membership dues and a change to In-District Temp and Out-District club member payment procedures.

- A. <u>In-District Regular & Temp Member</u>. In-District Regular Membership Dues are \$360.00 annually (\$30.00 per month).
- B. <u>In-District Senior & Temp Seniors</u>. In-District Senior Membership Dues are \$180.00 annually (\$15.00 per month).
- C. <u>Out-District Regular Temp</u>. Out-District Regular Membership Dues are \$720.00 annually (\$60.00 per month).
- D. <u>Out-District Senior Temp</u>. Out-District Senior Membership Dues are \$420.00 annually (\$35.00 per month).
- E. <u>Out-District Tennis Only.</u> Out-District Tennis Only Membership Dues are \$360.00 annually (\$30.00 per month).

Membership Dues shall be payable as follows:

Monthly installments may be added to the In-District residents' water bill for In-District homeowners only (does not include In-District lease tenants).

For In-District Temporary Membership (lease tenants), a minimum of 3, 6, or 12 months dues must be paid at the time of application. Renewals must be made in 3, 6, or 12 month increments at the Club office prior to expiration or through online billing.

For Out-District Temp & Tennis Only, a minimum of 3, 6, or 12 months dues must be paid at the time of application. Renewals must be made in 3, 6, or 12 month increments at the Club office prior to or on expiration or through online billing.

The dues increase will show up on In-District water bills in February, but are in effect as of January 1st, 2021.

For ALL Out-District temp members, snail mail billing will stop after the January bill! You must stop by the office to change over to the new 3, 6 or 12 month billing through the club.

Temp members billed through the club will have 2 options for payment. A reminder of membership expiration will go out by email. You may renew the membership through a payment link in the email, or you may come into the club for in-person renewal every 3, 6 or 12 months.
