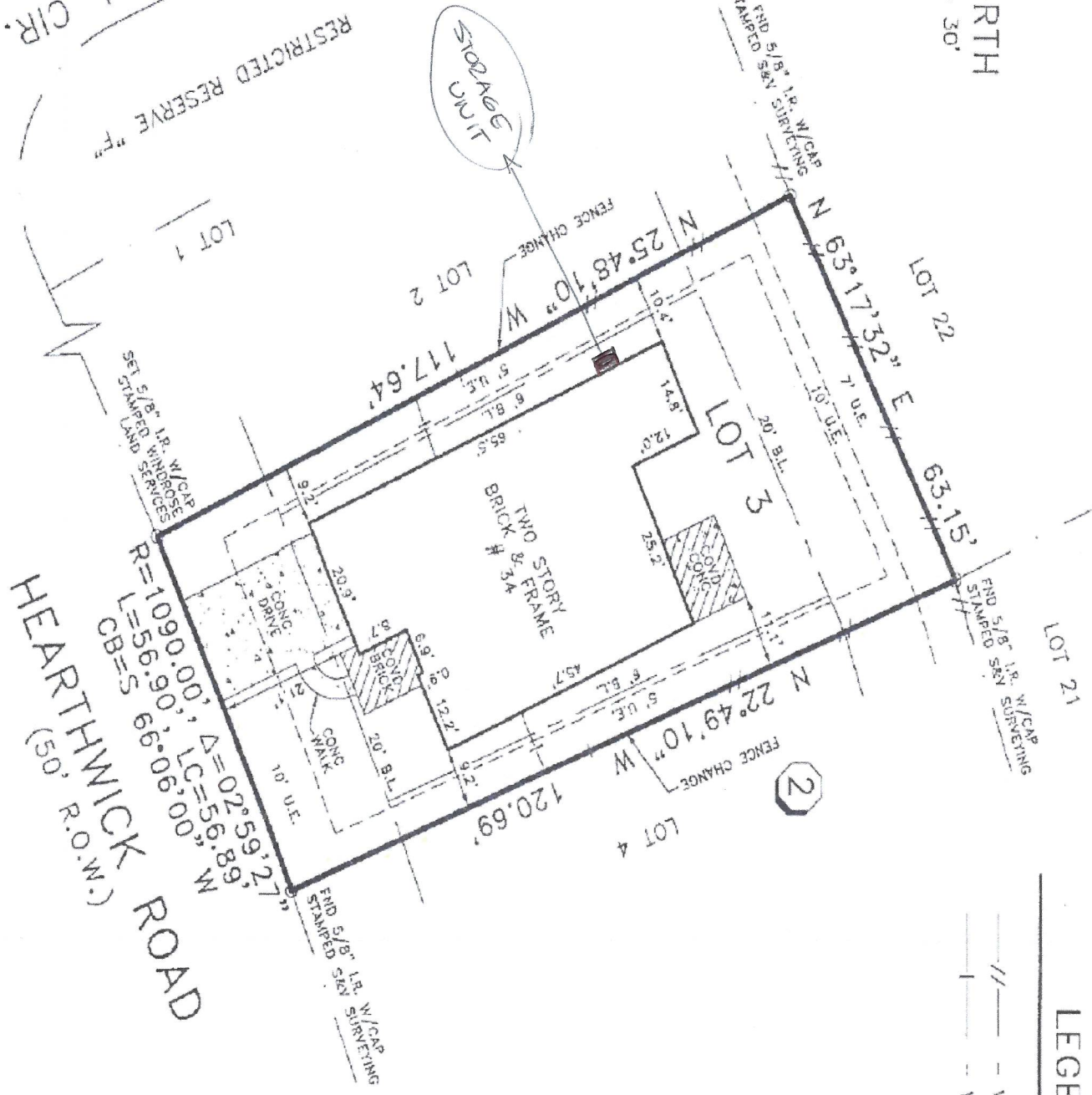

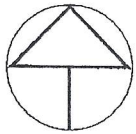


HEARTHWICK ROAD

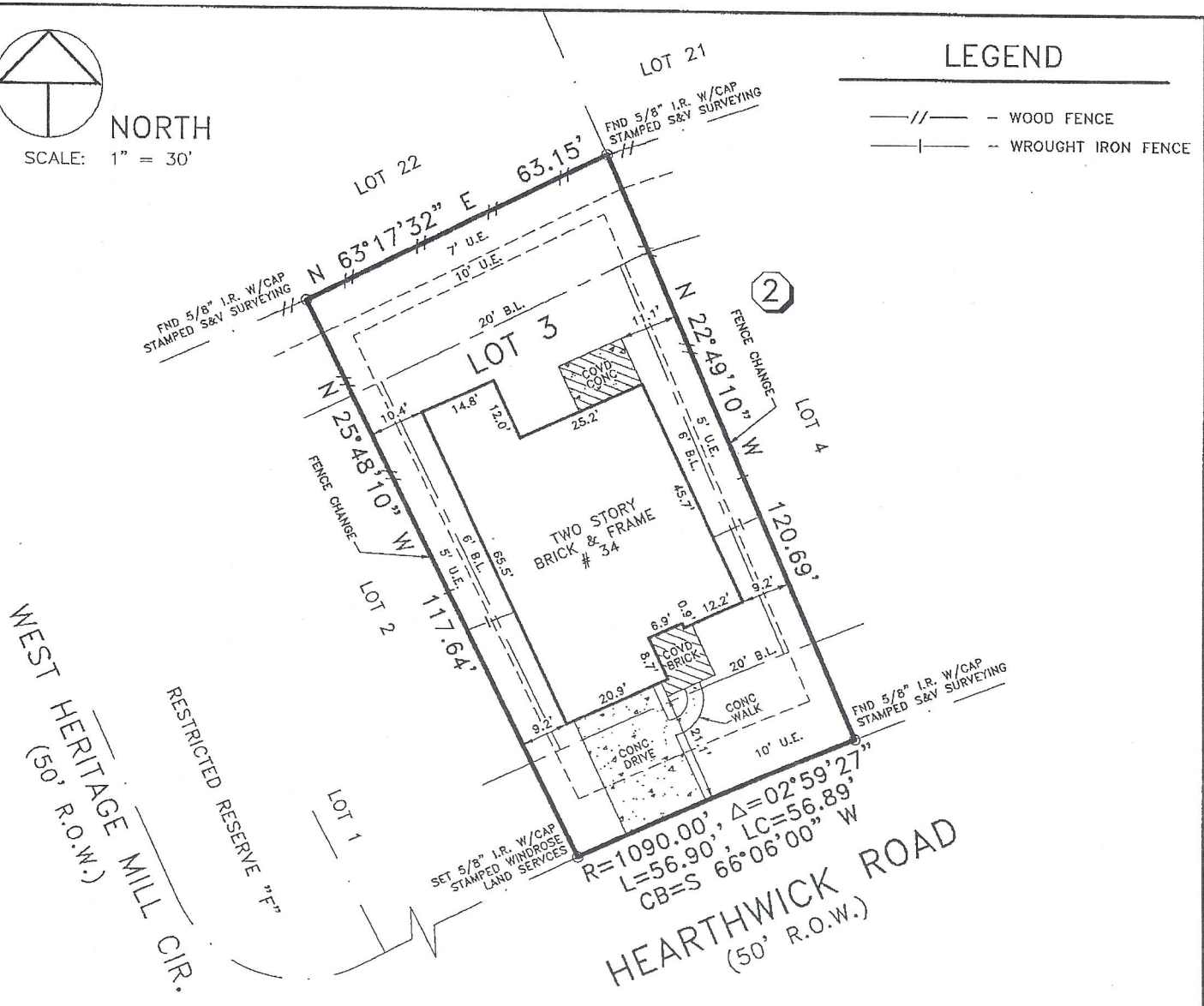

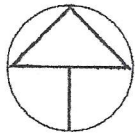

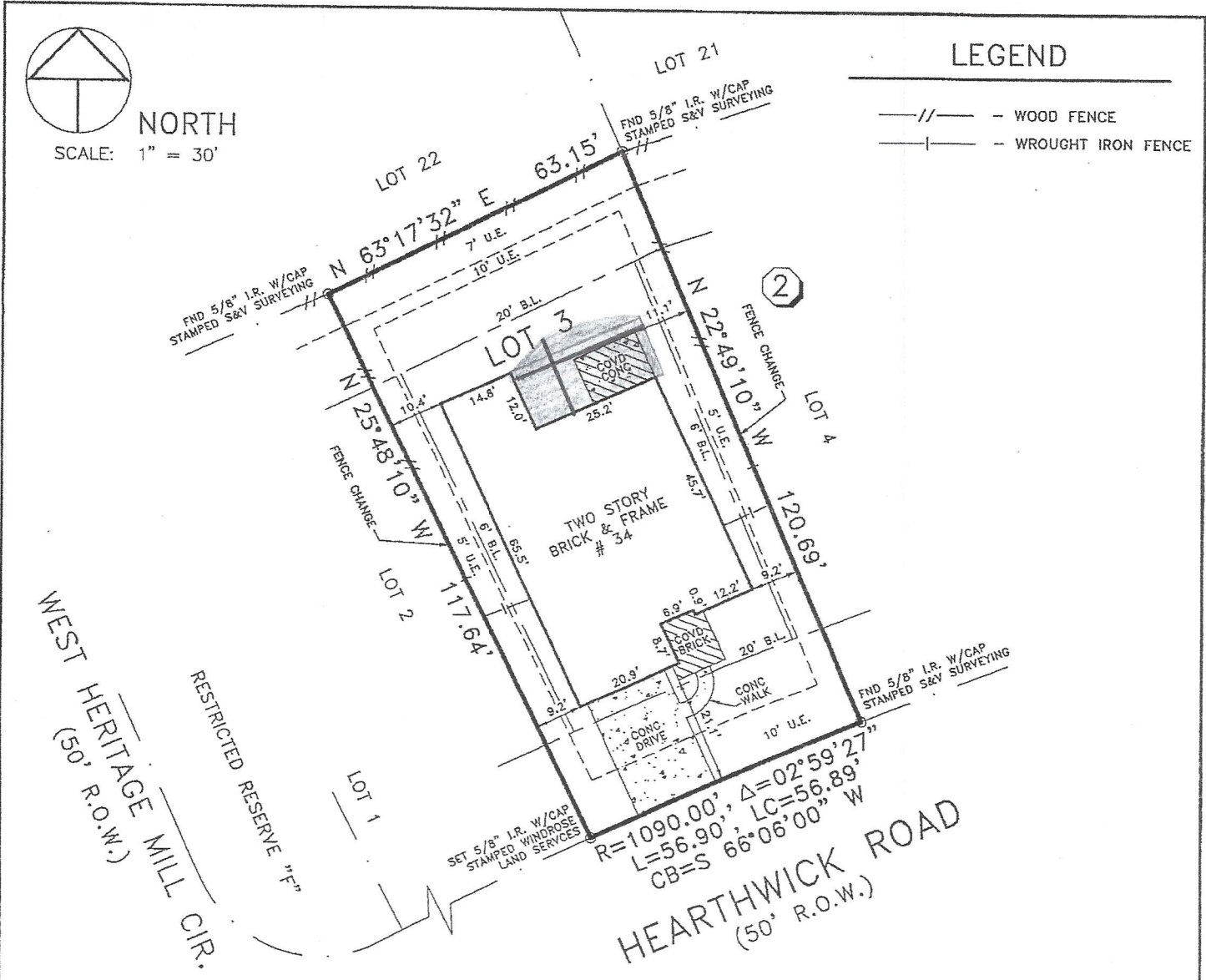
