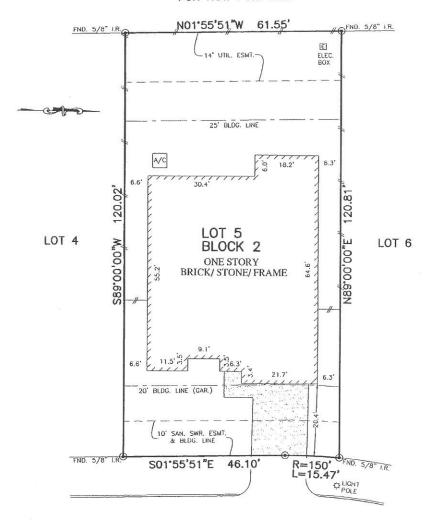
BAUER ROAD (66' R.O.W.)
