CLAIMS PROCEDURE

ibmit Warranty claim is writing by certified mail to Storm Tight Inc. The aim Notice must state the date of installation, the date and number of s Certificate, and include Proof of Purchase. This warranty shall be for benefit of the original purchaser/property owner, and shall be nsferable. Upon transferal the Warranty will convert to a 20 year non-prated limited warranty from the original Warranty, along with a dement of his or her name and the address of the property by certified all to Storm Tight Inc. at the address shown above within fifteen (15) ys after becoming the succeeding property owner. It is limited to the mulacturer furnishing new glass, free of charge, E.O.B. Dealer. In the ant of such replacement, the remaining portion of the original warranty food shall continue in effect and cover the replaced glass.
