-During the freeze of 2021, a pipe burst in the attic, impacting the kitchen ceiling, the kitchen hallway ceiling, and the exterior wall of the master bath. The pipe was replaced, the kitchen and kitchen hallway ceiling replaced and the sheetrock of the master bath exterior wall, midpoint down, from the vanity area to the far end of the extended shower, except for under the bathroom window, was also replaced. Since the old vanity and tub were removed, a new vanity, and a new, oversized, glass shower was installed. A new tile floor was also installed and the room painted.

-In 2020, Carpenter Ants were found in the two columns at front entrance of house. The columns were replaced and the area treated. There was no further evidence of ant activity.

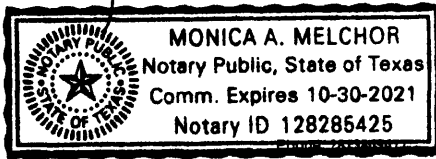
