Our rule is the same, the lot must be 1.5 acres but, with that being said Country Run subdivision was grandfathered in before our order changed and 1 acre is allowable. The setbacks must still be followed for septic and wells: The septic system must have a 50' setback from the well if the well is pressured cemented or 100' if it is not.
