## **DEVELOPER'S REPORT**

Industry headlines have been dominated lately by the blistering pace of home price appreciation fueled by increased demand, limited inventory, and rising costs of raw materials. This has especially been true for suburban master-planned communities such as The Falls, as families continue to search for well-located communities with great schools and well-built homes.

The Falls currently does not have any actively selling opportunities for new construction, however Partners In Building is completing the construction on a few homes to close out "The Cove". We are watching continued significant growth in surrounding communities as well, which will help further commercial development along the Grand Parkway.

Within The Falls our landscape maintenance contractor has begun the process of revitalizing the landscaping throughout, specifically a number of plants that were damaged by the winter storm as well as planned "fill-ins" previously scheduled due to aging landscaping and other damages. It was no easy feat securing plants, which are coming from as far away as Florida in order to complete the job.

<u>Summer HOA Meeting</u>: For the first time since our 2019 annual meeting, the HOA is hosting an in-person HOA meeting for June 10<sup>th</sup> at 6:30 p.m., to be held at Bradley Elementary. We look forward to being in attendance and providing development and project updates. Also, we will have a door prize of four Astro's tickets to a summer baseball game.

<u>YMCA:</u> Construction has officially commenced on Phase One of the Holcomb Family YMCA! You have probably seen the construction activity along Imperial Promenade near the Grand Parkway, and we appreciate your patience during the process. Site work is underway and the facilities are scheduled to be open in The Fall of 2021. A ground-breaking ceremony scheduled for April 23<sup>rd</sup> had to be cancelled due to weather and an alternate date is pending. <u>Lake Holcomb Updates</u>: One of our local youth group of volunteers recently installed many wood duck, owl and bat habitats surrounding Lake Holcomb. This is a great addition and the volunteers had fun installing. Recently planted trees and saplings donated by Trees For Houston and installed by Falls at Imperial Oaks volunteers are flourishing. The park continues to get significant use, and at times, people violating the rules such as riding ATV's and off road vehicles on the trail system and surrounding private property. Additional signs are being fabricated to more clearly define the rules and boundaries, however please be advised that law enforcement will be monitoring and prosecuting for these activities. Please continue to pick up trash that others have left behind and report rule violations to the Lake Club office or illegal activity to the Constable's office at (281) 364-4211.

If you or anyone you know is interested in organizing a community service project (i.e. Eagle Scout projects, school or church group community service projects), there are opportunities within Lake Holcomb Recreation Area that may be a great fit, and provide long-lasting benefit to the area. Please contact us for more information on how to get involved.

<u>Future Commercial - Grand Parkway and Imperial Promenade:</u> Retail space demand is getting stronger across the region, as more and more people are vaccinated and getting back to normal life again. The future retail center is being leased by Fidelis Realty Partners, and discussions are ongoing with many prospects to occupy space within the project. We believe that by the end of this year we will have an exciting lineup of anchor tenants to announce.

Trash service provided to Falls residents includes heavy trash pickup on each pickup day, and special pickups can be arranged as well. #### FALLS AT IMPERIAL OAKS HOA 2021 POOL REGISTRATION AND POOL SCHEDULE

Both Falls at Imperial Oaks swimming pools (The Lake Club and The Retreat), are available to residents of The Falls at Imperial Oaks who are current in assessments AND have wristbands and an access card. **WRISTBANDS:** Residents (ages 4 and over) must have their wristband on at all times while at the pool. Cost to replace lost or stolen wristband is \$5.00. To obtain free wristbands, see the pool registration dates below.

- 4-10 years old will receive a yellow wristband
- 3 years old and under will not need a wristband

**<u>GUEST POLICY</u>**: Guests must not be residents of The Falls at Imperial Oaks. Guests will be required to sign in. Residents are allowed 4 guests per household per day. **Saturdays and Sundays** require a guest fee of \$3.00 per guest (4 guests maximum) that can be paid to the pool gate attendant. Residents bringing 5 or more guests at anytime to the pool must book a party through the Lake Club office at least 2 weeks prior.
