

FIELD NOTES Of A Survey Of

A tract or parcel of land containing 1.9736 acres of land, more or less, being out of the B.B.B. & C.R.R. Co. Survey, Abstract 159, Brazoria County, Texas, and said tract being more particularly described by metes and bounds as follows:

BEGINNING at a ½ inch iron rod set with cap "Survey 1" for the Southwest corner of Lot 1, Block 1, of Tovrea Addition, an addition in Brazoria County, Texas according to the map or plat recorded in Volume 5, Page 290 of the map records of Brazoria County, Texas;

THENCE South 89° 26' 00" East, along the South line of said Tovrea Addition, a distance of 190.50 feet to a 1 inch iron pipe found for the most Easterly Northeast corner of the herein described tract of land, said point also being the Southeast corner of said Tovrea Addition and being in the Westerly right-of-way line of Tovrea Road (60' R.O.W.);

THENCE South 16° 28' 00" West, along the Westerly right-of-way line of said Tovrea Road, a distance of 46.79 feet to a ½ inch iron rod set with cap "Survey 1" for the most Easterly Southeast corner of the herein described tract of land, said point also being the Northeast corner of the Michael L. Dearing Tract (96)009/809 and being in the Westerly right-of-way line of said Tovrea Road;

THENCE North 89° 26' 00" West, along the North line of said Dearing Tract, a distance of 177.24 feet to a ½ inch iron rod set with cap "Survey 1" for an interior corner of the herein described tract of land, said point also being the Northwest corner of said Dearing Tract;

THENCE South, along the West lines of said Dearing Tract and the Betty A. Weber Tract as recorded in (94)034/463, a distance of 484.53 feet to a ½ inch iron rod set with cap "Survey 1" for the Southeast corner of the herein described tract of land, said point also being the Southwest corner of said Weber Tract and being in the North line of the William R. & Diane J. Tilley Tract (0159-0025-000);


THENCE West, along the North line of said Tilley Tract, a distance of 128.00 feet to a ½ inch iron rod set with cap "Survey 1" for the Southwest corner of the herein described tract of land, said point also being the Southeast corner of Dezso Addition as recorded in Volume 6, Pages 53-54 of the map records of Brazoria County, Texas and being in the North line of said Tilley Tract;

THENCE North, along the West line of said Dezso Addition, a distance of 607.00 feet to a ½ inch iron rod set with cap "Survey 1" for the Northwest corner of the herein described tract of land, said point also being the Southwest corner of the Brazoria County Day Care Center of Alvin Tract as recorded in Volume 1230, Page 193 and being in the West line of said Dezso Addition;

THENCE East, along the South line of said Brazoria County Day Care Center of Alvin Tract, a distance of 128.00 feet to a ½ inch iron rod set with cap "Survey 1" for the Northeast corner of the herein described tract of land, said point also being in the West line of said Tovrea Addition;

THENCE South, along the West line of said Tovrea Addition, a distance of 77.47 feet to the POINT OF BEGINNING of the herein described tract of land and containing 1.9736 acres of land, more or less.
