Water Damage Not Due to a Flood Event – 2015 -Water from outside flower bed entered utility room when water ponded from too high surrounding edging and damaged bottom of a cabinet under the window, fully repaired and drainage revised to not allow water penetration. 2016 - Heavy rain water entered master bedroom sunken area due to a crack in cement edge by door frame, we filled in the sunken section of the master bedroom so it is no longer lower than exterior deck thus preventing any further issues. 2016 - Wind driven rain came in through master bedroom siding/window connection damaging upper master bedroom floor. We replaced all the siding on the rear to Hardi plank and sealed around all windows to prevent water penetration. No further issues. 2017 - Leak from copper pipe in wall behind secondary bath caused damage to the office ceiling. We were in the office when it started so caught it early. We repaired the pipe and fixed the ceiling. 2021 - Copper pipe above outdoor covered patio burst in the freeze. We opened the ceiling, repaired and insulated all pipes in the area then fixed the ceiling. No further issues
