METES AND BOUNDS DESCRIPTION OF A 0.8462 ACRE TRACT OF LAND BEING ALL OF THAT CALLED 0.8462 ACRE TRACT OF LAND DESCRIBED IN DEED TO JIM CUNNINGHAM AND JOAN TODD RECORDED IN VOLUME 2607, PAGE 638 OF THE OFFICIAL RECORDS OF FORT BEND COUNTY TEXAS AND ALSO BEING ALL OF LOT 1 AND THE EAST 21 FEET OF LOT 2 OF THE EDGEWOOD ADDITION ANNEX NO. 8 RECORDED IN VOLUME 283, PAGE 429 OF THE DEED RECORDS OF FORT BEND COUNTY, TEXAS (D.R.F.B.C.,TX) AND SITUATED IN THE WILLIAM MORTON SURVEY, ABSTRACT NO. 62 IN FORT BEND COUNTY, TEXAS. SAID 0.8462 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a 1/2 inch iron rod found in the south right of way line of Riveredge Drive (60 foot right of way) and the north line of Lot 1 marking the northwest corner of said 0.8462 acre tract and the northeast corner of a called 0.8914 acre tract of land described in deed to George A. Harper recorded in Instrument No. 2015096550 of the Official Public Records of Fort Bend County, Texas (O.P.R.F.B.C.,TX);

THENCE with the south right of way line of Riveredge Drive, the north line of Lot 1 and the north line of said 0.8462 acre tract **South 78 degrees 37 minutes 25 seconds East** at 21.00 feet **passing** a 3/4 inch iron pipe in concrete found marking the northeast corner of Lot 1 and the northwest corner of Lot 2 and continuing in all a **total distance of 142.00 feet** to a 3/4 inch iron pipe in concrete found marking the northeast corner of Lot 2, the northeast corner of said 0.8462 acre tract, the northwest corner of Lot 3 and the northwest corner of a called 0.88533 acre tract of land described in deed to Jimmy L. Rude, Jr. recorded in Instrument No. 2002043346 O.P.R.F.B.C.,TX;

THENCE with the east line of said 0.8462 acre tract, the east line of Lot 2, the west line of Lot 3 and the west line of said 0.88533 acre tract **South 11 degrees 22 minutes 35 seconds West** at 150.00 feet **passing** the calculated southeast corner of Lot 2 and the southwest corner of Lot 3 and continuing in all a **total distance of 277.18 feet** to a 3/4 inch iron rod found marking the southeast corner of said 0.8462 acre tract from which the calculated southwest corner of said 0.88533 acre tract bears South 11 degrees 22 minutes 35 seconds West 15.00 feet;

THENCE with the south line of said 0.8462 acre tract **North 64 degrees 42 minutes 32 seconds West 146.29 feet** to a 1 inch iron pipe found in the east line of said 0.8914 acre tract marking the southwest corner of said 0.8462 acre tract from which a 1-1/4 inch iron pipe found for reference bears South 11 degrees 56 minutes 22 seconds West 85.10 feet;

THENCE with the west line of said 0.8462 acre tract and the east line of said 0.8914 acre tract **North 11** degrees 22 minutes 35 seconds East at 92.00 feet passing the south line of Lot 1 and continuing in all a total distance of 242.00 feet to the **POINT OF BEGINNING** of the herein described tract and containing 0.8462 acres within these metes and bounds.
