TRACT 1:

Being a tract of land situated in the John Baker 1/3 League, Abstract No. 71, Waller County, Texas, same being that tract of land conveyed to Raul A. Velasquez, Jr., and spouse, Sonia P. Velasquez, by deed recorded in Volume 1096, Page 379, Deed Records of Waller County, Texas (Tract 1), and being more particularly described

BEGINNING at a 1 inch iron pipe found for corner, said corner being the Northwest corner of that tract of land conveyed to Brenda J. THENCE South 00 degrees 51 minutes 10 seconds East, along the West line of said Kaiser tract, a distance of 172.70 feet to a 5/8 inch iron rod found for corner, said corner being the Northeast corner of that tract of land conveyed to William Charles Toth and spouse, Julie Kay Toth, by deed recorded in Instrument No. 1902456, Official Public Records of Waller County, Texas;

THENCE South 88 degrees 55 minutes 58 seconds West, along the North line of said Toth tract, a distance of 1073.68 feet to a 5/8 inch iron rod found for corner, said corner being the Northwest corner of said Toth tract and lying along the Southeast line of Jeff Smith Road (60 foot right-of-way);

THENCE North 43 degrees 57 minutes 25 seconds East, along the aforementioned Southeast line of Jeff Smith Road, a distance of 245.19 feet to a 5/8 inch iron rod found for corner, said corner being the Southwest corner of the remainder of said Velasquez tract (Tract 2);

THENCE North 88 degrees 15 minutes 03 seconds East, along the South line of said remainder tract, a distance of 450.30 feet to a 5/8 inch iron rod found for corner, said corner being the Southwest corner of aforesaid

THENCE North 89 degrees 41 minutes 27 seconds East, along said South line of Crockett tract, a distance of 450.65 feet to the POINT OF BEGINNING and containing 173,376 square feet or 3.98 acres of land.

BEGINNING at a 5/8 inch iron rod found for corner, said corner being the Southwest corner of that tract of land conveyed to Cory Wayne Crockett and Shelly Kay Crockett, by deed recorded in Instrument No. 1708878, Official Public Records of Waller County, Texas and lying along the North line of the remainder of said Velasquez tract (Tract 1);

THENCE South 88 degrees 15 minutes 03 seconds West, along the said North line of said remainder tract, a distance of 450.30 feet to a 5/8 inch iron rod found for corner, said corner being the Northwest corner of said remainder tract and lying along the Southeast line of Jeff Smith Road (60 foot right-of-way);

THENCE North 43 degrees 57 minutes 25 seconds East, along the aforementioned Southeast line of Jeff Smith Road, a distance of 199.58 feet to a 1/2 inch iron rod set with yellow plastic cap stamped "CBG Surveying" for corner, said corner being the beginning of a tangent curve turning to the left, with a radius of 1175.93 feet, a delta angle of 32 degrees 21 minutes 13 seconds, a chord bearing of North 27 degrees 46 minutes 48 seconds East, and a chord length of 655.23 feet;

THENCE South 00 degrees 29 minutes 52 seconds East, along the West line of said Crockett tract, a distance of 709.67 feet to the POINT OF BEGINNING and containing 121,106 square feet or 2.78 acres of land.
