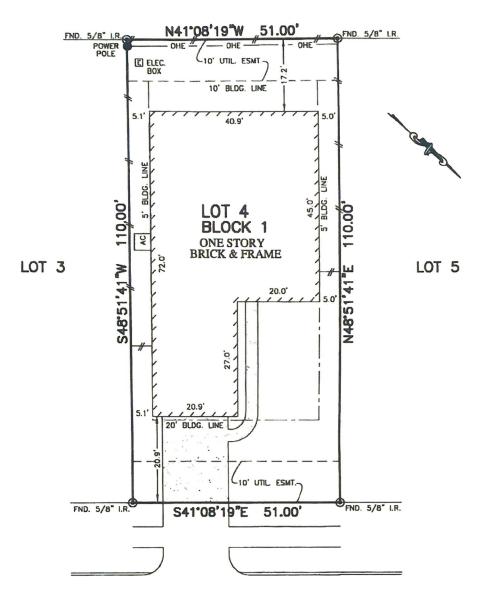
OHIO STREET (70' R.O.W.)
