"Floodway" means an area that is identified on the flood insurance rate map as a regulatory floodway, which includes the channel of a river or other watercourse and the adjacent land areas that must be reserved for the discharge of a base flood, also referred to as a 100-year flood, without cumulatively increasing the water surface elevation more than a designated height.

"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.

Filed a claim in 2008 after a hurricane Ike and again in 2017 for light flood damage after hurricane Harvey.

After IKE we received FEMA assistance for flood related expenses and lender flood insurance policy proceeds for damages. Additionally, in 2012 we were approved for Galveston Housing Authority Disaster Housing Assistance Program contractor services to complete hurricane Ike repairs. We vacated the premises for approximately 1 year while GHA contractors effected repairs not yet done in 2008 and 2009. Total renovations were reported to be \$50,000.



Texas Windstorm provided approximately \$2800 in proceeds for a small amount of loose shingles found in the yard after Hurricane Harvey. We funded a private contractor with 50 % of asking price to repair roof. Contractor did not do the work and skipped area. Remaining funds were used for cleaning garage of flood debris.
