Assessments

The 2021 assessment has been set at \$646.00. The trash calculation has been set at \$211.83 and the Fire Services Agreement fee has been set at \$270.02.

If your assessment amount is \$1127.85 then you own a lot with a house upon it in non-Rosenberg, you receive trash services from WCA (\$211.83) and have been billed for FSA (\$270.02).

The 2021 general assessment represents a 0% increase over prior year's assessments.

Assessment Due Date: Assessments are billed annually and are due on January 1st and become delinquent on January 31st.


