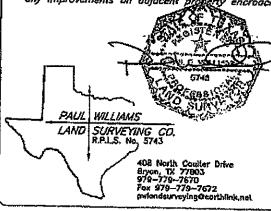


## Terrence Johnson and Holly Johnson
