FIELD NOTES of an 11.4626 acre tract of land situated in the T. Toby (Walter Gregory Survey, Abstract 782) and the T. Toby (Walter Gregory Survey, Abstract 783), Harris County, Texas and being out of and a part of that certain 668.0726 acres (Parcel One) conveyed by Brown Brothers Farm, Inc. to Billy E. Murff by Assumption Deed dated January 14, 1983 and recorded under County Clerk's File No. H985029 of the Deed Records of Harris County, Texas. Said 11.4626 acres being all of that certain 5.968 acres (Tract One) and all of that certain 5.494 acres (Tract Two) conveyed by Richard Johns to Billy Everett Murff and wife, Elizabeth Elaine Murff, by Deed dated October 31, 1994 and recorded under County Clerk's File No. R141460 of the Official Public Records of Recal Property of Harris County, Texas. This 11.4626 acre tract of land is more particularly described by the following metes and bounds, to-wit:

NOTE: BEARINGS ARE BASED ON DEED BEARINGS AND FOUND MONUMENTS IN THE SOUTHERNMOST EAST LINE OF SAID 668.0726 ACRES. REFERENCE IS MADE TO THE PLAT OF EVEN DATE ACCOMPANYING THIS METES AND BOUNDS DESCRIPTION.

COMMENCING at a 3/4 inch iron rod (bent) found for the most Southerly Southeast corner of said 668.0726 acres.

THENCE: North 00°19'41" West along the approximately centerline of Seaberg Road and the Southernmost East line of said 668.0726 acres for a distance of 3794.18 feet to a 5/8 inch iron rod found in the edge of an existing ditch for the Southeast corner of said 5.968 acres and the Southeast corner and POINT OF BEGINNING of this tract. Said point is called to be in the North right-of-way line of Wolcek Road (called 60 feet wide right-of-way).

THENCE: South 89°36'40" West along the South line of this tract, the South line of said 5.968 acres and the called North right-of-way line of said Wolcek Road and at 162.50 feet pass a point for the Southwest corner of said 5.968 acres and the Southeast corner of said 5.494 acres; from which a 1/2 inch iron rod, with cap (BHA), set for reference, bears North 00°19'41" West 5.00 feet; in all, a total distance of 312.10 feet to a point in said ditch for the Southwest corner of this tract and the Southwest corner of said 5.494 acres.

THENCE: North 00°19'41" West along the West line of this tract and the West line of said 5.494 acres and at 5.00 feet pass a 5/8 inch iron rod (bent) found in the occupied North right-of-way line of said Wolcek Road at the Southeast corner of that certain called 8.70 acres conveyed by Arthur C. Burns, et ux, to William C. Bugbee, Jr., et ux, by Decd dated June 6, 2008 and recorded under County Clerk's File No. 20080297560 of the Official Public Records of Real Property of Harris County, Texas; in all, a total distance of 1599.84 feet to a 5/8 inch iron rod found in a South line of the residue of said 668.0726 acres for the Northwest corner of this tract, the Northwest corner of said 5.494 acres and the Northeast corner of said called 8.70 acres.

THENCE: North 89°36'40" East along the North line of this tract, the North line of said 5.494 acres, the North line of said 5.968 acres and the South line of said residue tract and at 149.60 feet pass a 5/8 inch iron rod found for the Northeast corner of said 5.494 acres and the Northwest corner of said 5.968 acres; in all, a total distance of 312.10 feet to a 1-1/2 inch iron pipe found for the Northeast corner of this tract, the Northeast corner of said 5.968 acres, an interior corner of said 668.0726 acres and the Northwest corner of that certain called 276.6 acres conveyed by James Anderson Wells, et ux, to J. D. Wells by Deed dated May 3, 1979 and recorded under County Clerk's File No. G075317 of the Deed Records of Harris County, Texas.

THENCE: South 00°19'41" East along the East line of this tract, the East line of said 5.968 acres, the Southernmost East line of said 668.0726 acres and the West line of said 276.7 acres and at 1584.92 feet pass a fence corner; at 1594.84 feet pass a 1/2 inch iron rod, with cap (BHA), set for reference in the occupied North right-of-way line of said Wolcek Road; in all, a total distance of 1599.84 feet to the PLACE OF BEGINNING and containing within these boundaries 11.4626 acres; of which 0.036 of an acre lies within the limits of the occupied right-of-way of said Wolcek Road.
