The district may exercise the authority without holding an election on the matter. As of this date, the most recent amount of the standby fee is $\frac{0}{2}$. An unpaid standby fee is a personal obligation of the person that owned the property at the time of imposition and is secured by a lien on the property. Any person may request a certificate from the district stating the amount, if any, of unpaid standby fees on a tract of property in the district.
