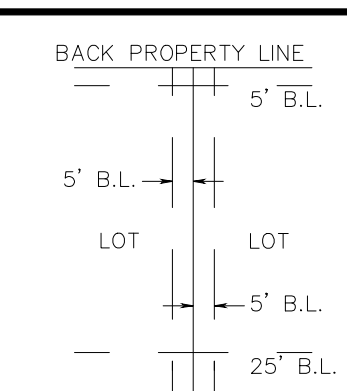

 - 2.) EASEMENTS ARE HEREBY RESERVED AS SHOWN TO FACILITATE ROADWAYS, DRAINAGE AND INSTALLATION OF UTILITIES, INCLUDING BUT NOT LIMITED TO ELECTRICAL LINES, WASTE WATER DISPOSAL LINES, GAS AND WATER LINES.  - 4.) ALL DRAINAGE EASEMENTS SHALL BE KEPT CLEAR OF FENCES, BUILDING, PLANTING AND OTHER OBSTRUCTIONS TO THE OPERATIONS AND MAINTENANCE OF DRAINAGE FACILITY, AND ADJUTING PROPERTY SHALL NOT BE PERMITTED TO DRAIN INTO THIS EASEMENT EXCEPT BY MEANS OF AN APPROVED DRAINAGE STRUCTURE.

 - 7.) SOUTHWINDS SECTION 2 WILL FOLLOW THE DECLARATION OF COVENANTS AND RESTRICTIONS "EXHIBIT C" RESTRICTIVE COVENANTS FOR 200.87 ACRES - KILGORE PARKWAY AND HIGHWAY 146, CHAMBERS COUNTY, TX.
 - 8.) SOUTHWINDS SECTION 2 WILL BE SINGLE FAMILY RESIDENTIAL WITH 5.03 LOTS PER ACRE.
 - 9.) REFERENCE DRAINAGE REPORT TITLED: "KILGORE REGIONAL DRAINAGE PLAN - PLAN B ALTERNATE 4"
 - 10.) **FLOODPLAIN:** ACCORDING TO THE FLOOD INSURANCE RATE MAPS NO. 480701D10E DATED MAY 4, 2015, THE 21.46 ACRE TRACT SHOWN HEREON IS SITUATED ENTIRELY IN ZONE "X" (UNSHADED) AND IS IN AN AREA DETERMINED TO BE OUTSIDE THE 500-YEAR FLOODPLAIN.
 - 11.) A MAILBOX INSTALLATION THAT CONFORMS TO THE FOLLOWING CRITERIA WILL BE CONSIDERED ACCEPTABLE UNLESS IN THE JUDGMENT OF THE CHAMBERS COUNTY COMMISSIONERS COURT, THE INSTALLATION INTERFERES WITH THE SAFETY OF THE TRAVELING PUBLIC OR THE FUNCTION, MAINTENANCE OR OPERATION OF THE COUNTY ROADWAY SYSTEM.
 - FOR ROADWAYS HAVING A SPEED LIMIT GREATER THAN 40 MPH, THE FACE OF THE MAILBOX MUST BE SET BACK A MINIMUM OF 3 FEET FROM THE EDGE OF THE PAVEMENT AND MUST BE MOUNTED ON A BREAK-A-WAY POST OR FORMING TO THE STANDARDS ADOPTED BY THE TEXAS DEPARTMENT OF TRANSPORTATION (TxDOT).

KEITH BEHRENS, PRESIDENT, OWNERS OF THE 21.462 ACRE TRACT DESCRIBED IN THE ABOVE AND FOREGOING MAP OF SOUTHWINDS SECTION TWO FINAL PLAT, WILLIAM BLOODGOOD AUGMENTED SURVEY, A-36 CHAMBERS COUNTY, TEXAS; AND DEDICATE TO PUBLIC USE AS SUCH, THE STREETS, ALLEYS, PARKS, AND EASEMENTS SHOWN HEREON FOREVER; AND DO HEREBY WAIVE ANY CLAIMS FOR DAMAGES OCCASIONED BY THE SURFACE OF ANY PORTION OF STREETS OR ALLEYS, TO CONFORM TO SUCH GRADERS; AND DO HEREBY BIND OURSELVES, OUR HEIRS, SUCCESSORS AND ASSIGNS TO WARRANT AND FOREVER DEFEND THE TITLE TO THE LAND SO DEDICATED.

THIS FINAL PLAT OF SOUTHWINDS SECTION TWO ACCURATELY REPRESENTS THE PROPOSED PLAN AND TYPE OF DEVELOPMENT OF THAT CERTAIN 21.462 ACRE TRACT OF LAND SHOWN HEREON. WE DO FURTHER DEDICATE TO THE PUBLIC ALL EASEMENTS AND PUBLIC UTILITIES THEREIN, AND WE HEREBY COVENANT AND RESTRICT THE LAND SHOWN HEREON THIS PLAT TO THE USES AS SHOWN ON THE PLAT; AND NO USE OF SUCH LAND, DIFFERENT FROM THAT SHOWN ON THE RECORDED PLAT SHALL BE MADE UNLESS AND UNTIL ALL ORDINANCE REQUIREMENTS OF THE CITY OF BAYTOWN AND THE LAWS OF THE STATE OF TEXAS APPLICABLE TO SUCH PROPOSED USES SHALL HAVE FIRST BEEN COMPLIED WITH.

FURTHER, OWNERS HAVE DEDICATED AND BY THESE PRESENTS DO DEDICATE TO THE USE OF THE PUBLIC FOR PUBLIC UTILITY PURPOSES FOREVER UNOBSTRUCTED AERIAL EASEMENTS THE AERIAL EASEMENTS SHALL EXTEND HORIZONTALLY AN ADDITIONAL ELEVEN FEET, SIX INCHES (11' 6") FOR TEN FEET (10' 0") PERMETER GROUND EASEMENTS OR SEVEN FEET, SIX INCHES (7' 6") FOR FOURTEEN FEET (14' 0") PERMETER GROUND EASEMENTS OR FIVE FEET, SIX INCHES (5' 6") FOR SIXTEEN FEET (16' 0") PERMETER GROUND EASEMENTS FROM A PLANE SIXTEEN FEET (16' 0") ABOVE GROUND LEVEL UPWARD, LOCATED ADJACENT TO AND ADJOINING SAID PUBLIC UTILITY EASEMENTS THAT ARE DESIGNED WITH AERIAL EASEMENTS (U.E. AND A.E.) AS INDICATED AND DEPICTED, WHEREBY THE AERIAL EASEMENT TOTALS THIRTY ONE FEET, SIX INCHES (31' 6") IN WIDTH.

FURTHER, OWNERS HAVE DEDICATED AND BY THESE PRESENTS DO DEDICATE TO THE USE OF THE PUBLIC FOR PUBLIC UTILITY PURPOSES FOREVER UNOBSTRUCTED AERIAL EASEMENTS THE AERIAL EASEMENTS SHALL EXTEND HORIZONTALLY AN ADDITIONAL TEN FEET (10' 0") FOR TEN FEET (10' 0") BACK-TO-BACK GROUND EASEMENTS, OR EIGHT FEET (8' 0") FOR FOURTEEN FEET (14' 0") BACK-TO-BACK GROUND EASEMENTS OR SEVEN FEET (7' 0") FOR SIXTEEN FEET (16' 0") BACK-TO-BACK GROUND EASEMENTS FROM A PLANE SIXTEEN FEET (16' 0") ABOVE GROUND LEVEL UPWARD, LOCATED ADJACENT TO BOTH SIDES AND ADJOINING SAID PUBLIC UTILITY EASEMENTS THAT ARE DESIGNED WITH AERIAL EASEMENTS (U.E. AND A.E.) AS INDICATED AND DEPICTED HEREON, WHEREBY THE AERIAL EASEMENT TOTALS THIRTY FEET (30' 0") IN WIDTH.

FURTHER, OWNERS DO HEREBY COVENANT AND AGREE THAT ALL OF THE PROPERTY WITHIN THE BOUNDARIES OF THIS PLAT AND ADJACENT TO ANY DRAINAGE EASEMENT, DITCH, GULLY, CREEK OR NATURAL DRAINAGE WAY SHALL HEREBY BE RESTRICTED TO KEEP SUCH DRAINAGEWAYS AND EASEMENTS CLEAR OF FENCES, BUILDINGS, PLANTING AND OTHER OBSTRUCTIONS TO THE OPERATIONS AND MAINTENANCE OF THE DRAINAGE FACILITY AND THAT SUCH ADJUTING PROPERTY SHALL NOT BE PERMITTED TO DRAIN DIRECTLY INTO THIS EASEMENT EXCEPT BY MEANS OF AN APPROVED DRAINAGE STRUCTURE.
