

COUNTY OF WASHINGTON

Land Description 0.597 Acres

BEING a tract or parcel containing 0.597 acres of land situated in Washington County, Texas and being Lots 72, 73, and 92 in the Lake Forest Subdivision according to the subdivision plat recorded in Volume 302, Page 263, Washington County Deed Records and also being composed of the following tracts of land; (1) all of that land described as Lot 73 and Lot 92 in Deed dated January 12, 2000, from Dorothy Griior Raines to Glenn A. Otness, et ux, recorded in Volume 949, Page 106, Washington County Official Records and (2) all of that land described as Lot 72 in Deed dated April 25, 2003, from Donald Bruce Grady, et ux, to Glenn A. Otness, et ux, recorded in Volume 1075, Page 408, Washington County Official Records. Said 0.597 acre tract being described more particularly by metes and bounds as follows:

BEGINNING at a ½" iron rod found for the South corner of Lot 92 and the South corner of the herein described 0.597 acre tract, located on the Northwest right of way line of Black Forest Lane (40 feet in width), said iron rod also being the East corner of Lot 91 of this same subdivision;

THENCE departing Black Forest Lane and along the common boundary between Lots 91 and 92, N 44° 42' 20" W a distance of 120.04 feet to a ½" iron rod found for the West corner of Lot 92, the South corner of Lot 73, and an angle corner of the herein described tract, said iron rod also being the North corner of Lot 91 and the Bast corner of Lot 74;

THENCE along the common line between Lots 73 and 74, N 44° 56' 36" W a distance of 114.99 feet to a 5/8" iron rod found on the Southeast line of Lake Forest Circle (40 feet in width) for the North corner of Lot 74 and being the West corner of Lot 73 and the West corner of the herein described tract;

THENCE along the Southeast line of Lake Forest Circle, which is also along the Northwest line of Lots 73 and 72, N 45° 13' 08" E a distance of 150.05 feet to a ½" iron rod found the North corner of Lot 72 and being the North corner of the herein described tract, also being the West corner of Lot 71;

THENCE leaving Lake Forest Circle and along the common boundary of Lots 71 and 72, S 44° 48° 54" E a distance of 114.90 feet to a ½" iron rod found for the East corner of Lot 72 and an Easterly exterior corner of the herein described tract, also being the South corner of Lot 71 located on the Northwest line of Lot 93.

THENCE along the Southeast line of Lot 72 common with the Northwest line of Lot 93, S 45° 22' 12" W a distance of 75.27 feet to a ½" iron rod found for the West corner of Lot 93, said iron rod also being the South corner of Lot 72, the North corner of Lot 92, and an interior corner of the herein described tract;

THENCE along the common line between Lots 92 and 93, S 43° 38' 10" E (Basis of Bearings – Record Plat Call) a distance of 120.32 feet to a ½" iron rod found on the Northwest line of Black Forest Lane for the East corner of Lot 92 and the most Southerly East corner of the herein described tract, also being the South corner of Lot 93;

THENCE along the Northwest line of Black Forest Lane, S 45° 11' 35" W a distance of 72.28 feet to the POINT OF BEGINNING, containing 0.597 acres of land.
