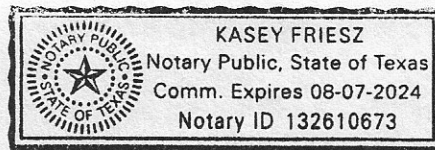
4. To the best of our actual knowledge and belief, since March 27, 2002 there have been no:
