#### LIMITED LIFETIME SERVICE AGREEMENT

If any adjustments are necessary during the first four (4) years from the completion date of the job, due to settling of the piers, AAA Foundation Service will adjust the piers at No Charge to the Homeowner. After the first four (4) years, any adjustment would be done at the rate of \$40.00 per pier. The Service Agreement applies only to the seventeen (17) exterior piers installed by AAA Foundation Service in 1989, which includes the following conditions:

- (1) Contractor will remove and replant shrubs and plants obstructing operations but is not responsible for their continued survival.
- (2) Structural defects or cracks, whether existing before or after foundation work, are the responsibility of the Owner. Contractor will not be liable for any redecorating, plumbing, electrical work, repairing or replacing of any materials other than pier/piling components.
- (3) When adjustments require breaking through concrete, Contractor will patch concrete but is not responsible for repairs or replacement of any coverings, including but not limited to tile, carpet, laminate, or hardwood.

#### TRANSFERABILITY

This Limited Lifetime Service Agreement may be transferred one time only. This Agreement is assignable by the owner of the contract if written notification is received in this office within thirty (30) days of closing date.
