1. You must be a resident and/or guest of a resident. Only two guests allowed per family.
2. Resident must be current on Annual Maintenance Fees and not have a balance due.
3. Resident must have a pool tag at all times while at the pool.
4. Rules are posted and will be strictly enforced. Violators will be asked to leave.
5. Pool parties are held after pool hours and must end at 11:00 p.m. Schedule your pool party at www.a-beautifulpools.com then click on HOA Manager/Resident Information and see "Pool Parties" tab on the right.

Children ages 10 and under must be accompanied by an individual 16 years or older.
