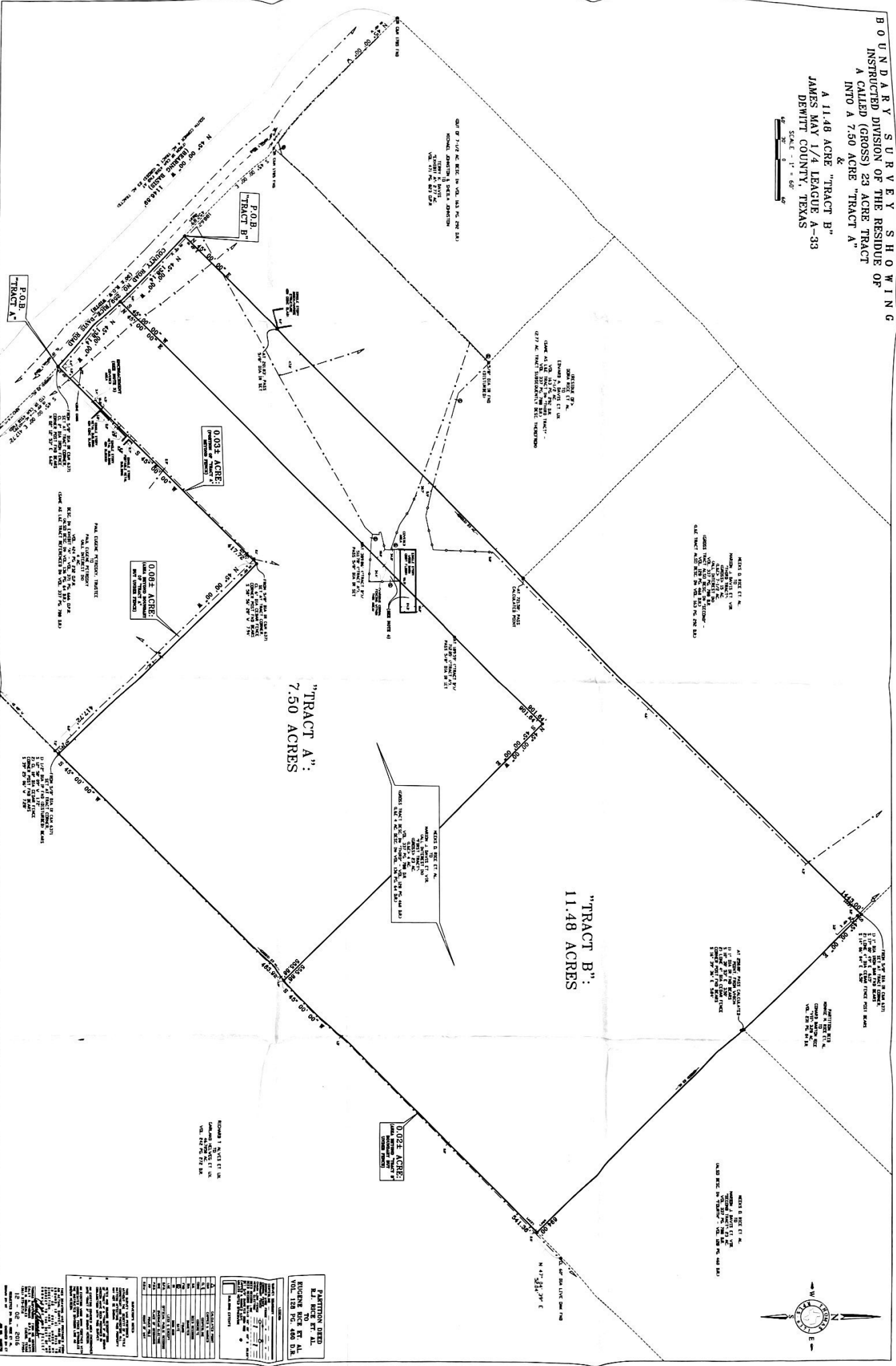
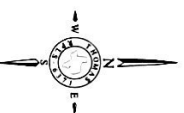


**BOUNDARY SURVEY SHOWING**
