
4. To the best of our actual knowledge and belief, since February 15, 2007 there have been no:

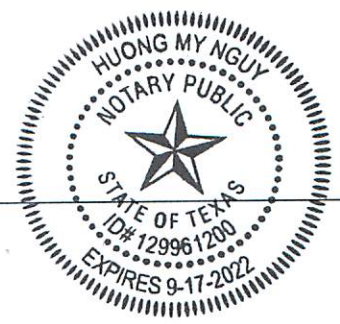

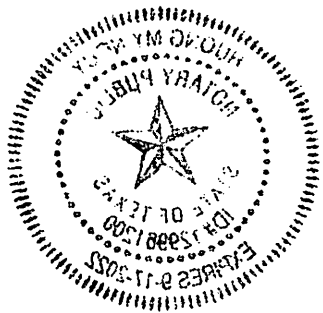
