Re: Misc. Issues

We as the members of your board of directors are aware of the items that need attention on the property. We have been unable to handle most of these items last year and this year for one reason.

As you all are aware after the death of Frances Long and the suicide of her daughter, Marsha the unit was inherited by her son-in-law Richard Owen. There were two insurance incidents in this unit and before the Association could do the insured repairs, he decided he wanted the money from the claims. As you know Westchester is a condominium, therefore, all insurance proceeds are for doing the repairs for which we were paid. Dr. Owen did not agree with this and sued the Association. There have been two depositions, two mediations and at the last mediation and agreement was agreed upon. Paperwork was drawn up by our attorney and sent over to Dr. Owen's attorney. All was agreed upon and the board signed the agreement. Dr. Owen's attorney then filed paperwork with the court to withdraw from being his counsel. After he agreed that they could withdraw from the case he changed his mind and now his law firm must wait for the court to agree with their withdrawal. This is another delay and we have been told it could be fall before they appear before the judge. Upon this happening Dr. Owen now wants to change the agreement, which was agreed upon. Rick Anderson, our attorney, has told us that there is nothing we can do until Dr. Owen's attorney is off the case. Then there is paperwork that we can file and finally have a settlement or ask for the case to be dropped.

All the legal fees are coming out of the Association funds. We filed with the insurance company however, since we received funds for the insurance claim this could not be handled by our liability or D&O insurance.
