Water Damage Not Due to a Flood Event – 1) Previous owners (thus before 2017) had a pipe break in the kitchen. According to their records this was promptly addressed the same day by Bionic Emergency Services, and performed water damage and mold treatment. Current owners did not notice any obvious issue in the past 4 years related to this. 2) Previous owners sold the house in 2017 with an issue in the primary bath shower: the tiles were warping and they did not repair or addressed the issue. It is unclear if this was due to leaks occurring for a prolonged period of time, and/or if it was a workmanship issue. Current owners fixed the underlying issue replacing small sections of wood beams and tiles in kind. Since then the shower presented no visible issues.

Previous treatment for termites or WDI – Previous owners disclosed that in 2012 termites were found under gravel of side patio, inspected and treated the area of the inside wall as a precaution. Current owners did not notice any issue from the time of purchase (2017), and simply continued standard routine treatments against bugs.

*A single blockable main drain may cause a suction entrapment hazard for an individual.

1) Pedestrian gate lock: tumbler detaches at times. 2) A/C condenser unit: it was not leveled at time of purchase, it did not progress over time, and did not create a problem in these years. 3) Hot/Cold water connections at laundry room: minor leak of few droplets per minute. These droplets drain directly into the drain pipe. If the washing machine is connected to the pipes, this is not visible.

We are unfamiliar with the HS Code, so we are unsure of what that entails. We confirm that the house has several smoke detectors distributed over the 3 floors, which we maintained over the years.
