BEGINNING at a found & Iron rod, being in the west right of way of highway F.M. 2666, and being the southwest corner of said 14.853 acres.

THENCE: North 01' 02' 29' West, along the west line of said 14.853 acre tract, to a property in the southwest corner of a 2,000 acre tract being out of and situated in the north end of said 14.853 acre tract, and being the northwest corner of this 13.4733 acre tract, for a distance of 1343.20 feet;

THENCE: North 88° 21' 66' East, along the north line of this 13.4733 acre tract, and along the south line of said 2.000 acre tract, being the east line of said 14.853 acre tract, for a distance of 477.61 feet!

THENCE: South 01* 29' 06' East, along the east line of said 14.853 acre tract, to a 1' iron rod, for a distance of 610.57 feet;

THENCE: South 50' 02' 07' East, along the east line of said 14.853 acre tract, for a \$' iron rod, being the west right of way of highway F.M. 2666, for a distance of 267.69 feet;


