THENCE North 53 degrees 48 minutes 06 seconds West, a distance of 80.44 feet (called North 54 degrees 34 minutes 22 seconds West, a distance of 80.46 feet) with the southwest line of said 0.50 acre tract, same being the common line of said 9.298 acre tract to a 1/2 inch iron rod with cap found for a corner of this herein described tract;

THENCE North 36 degrees 09 minutes 28 seconds East, a distance of 272.26 feet (called North 35 degrees 23 minutes 33 seconds West, a distance of 272.25 feet) with the northwest line of said 0.50 acre tract, same being the southeast line of said 9.298 acre tract to a 3/4 inch iron rod found for a corner of this herein described tract;
