FIELD NOTE DESCRIPTION OF A 1.0039 (CALLED 1.00) ACRE TRACT OF LAND SITUATED IN THE W.D. SMITH SURVEY, ABSTRACT NO. 23, CHAMBERS COUNTY, TEXAS, AND BEING A PORTION OF LOTS H AND I OF THE JOHN BEASLEY SUBDIVISION, ACCORDING TO THE MAP OR PLAT THEREOF RECORDED IN VOLUME 31, PAGE 306 OF THE DEED RECORDS OF CHAMBERS COUNTY, TEXAS, SAID 1.0039 ACRE TRACT BEING THE REMAINDER OF A CALLED 3.433 ACRE TRACT AS DESCRIBED IN DEED RECORDED IN VOLUME 109, PAGE 160 OF THE DEED RECORDS OF CHAMBERS COUNTY, TEXAS, SAVE AND EXCEPT A 1 ACRE TRACT TO WHITE AS DESCRIBED IN DEED RECORDS OF CHAMBERS COUNTY, TEXAS, AND CALLED 1.4298 ACRE TRACT TO RHONDA K. EASTMAN AS DESCRIBED IN VOLUME 487, PAGE 646 OF THE OFFICIAL PUBLIC RECORDS OF CHAMBERS COUNTY, TEXAS; SAID 1.0039 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING, at a 3/4 inch iron pipe found on the northwest line of Ocean Drive, a 60 foot wide Right-of-Way and the northeast line of a 50 foot wide unimproved Right-of-Way as shown on the plat of said John Beasely Subdivision;

THENCE, S 55°31'25" W, along the northwest line of Ocean Drive, passing at 50.00 a point for the east corner of said 1 acre White tract and the east corner of the said called 3.433 acre tract, and continuing for a total distance of 216.77 feet to a 1/2 inch iron rod found 0.55 feet northwest of the west corner of said White tract and the east corner and POINT OF BEGINNING of the herein described tract;

THENCE, S 55°31'25" W, continuing along the northwest line of said Ocean Drive and the southeast line of the said called 3.433 acre tract, a distance of 132.43 feet to a point for corner for the southerly corner of the herein described tract and said called 3.433 acre tract, from which a bent 1 inch iron pipe found bears S 69°42'07" E, a distance of 0.83 feet;

Thence, N 34°28'05" W, along the southwesterly line of the said called 3.433 acre tract, a distance of 289.86 feet to a 1 inch pipe found for the north corner of the Franz tract as described in deed recorded in Volume 159, Page 11 of the Official Public Records of Chambers County, Texas;

THENCE, N 34°11'42" W, along the southwesterly line of the said called 3.433 acre tract, a distance of 28.23 feet to a point for corner for the most southwesterly corner of the said Eastman tract and west corner of the herein described tract, from which a found chain link fence post bears S 67°00'00" E a distance of 1.21 feet;

THENCE, N 55°34'36" E, along a southerly line of the said Eastman tract, a distance of 142.15 feet, to a point for corner for an interior corner of the said Eastman tract and the most northerly corner of the herein described tract;

THENCE, S 33°04'08" E, along a line of the said Eastman tract, a distance of 49.33 feet, to a 1/2 inch iron rod marking the most southerly corner of the said Eastman tract and the most westerly corner of the White tract;

THENCE, S 32°37'26" E, along the southwesterly line of the said White tract, a distance of 268.79 feet to the POINT OF BEGINNING, containing within these calls 1.0039 acres or 43,732.8 square feet of land.
