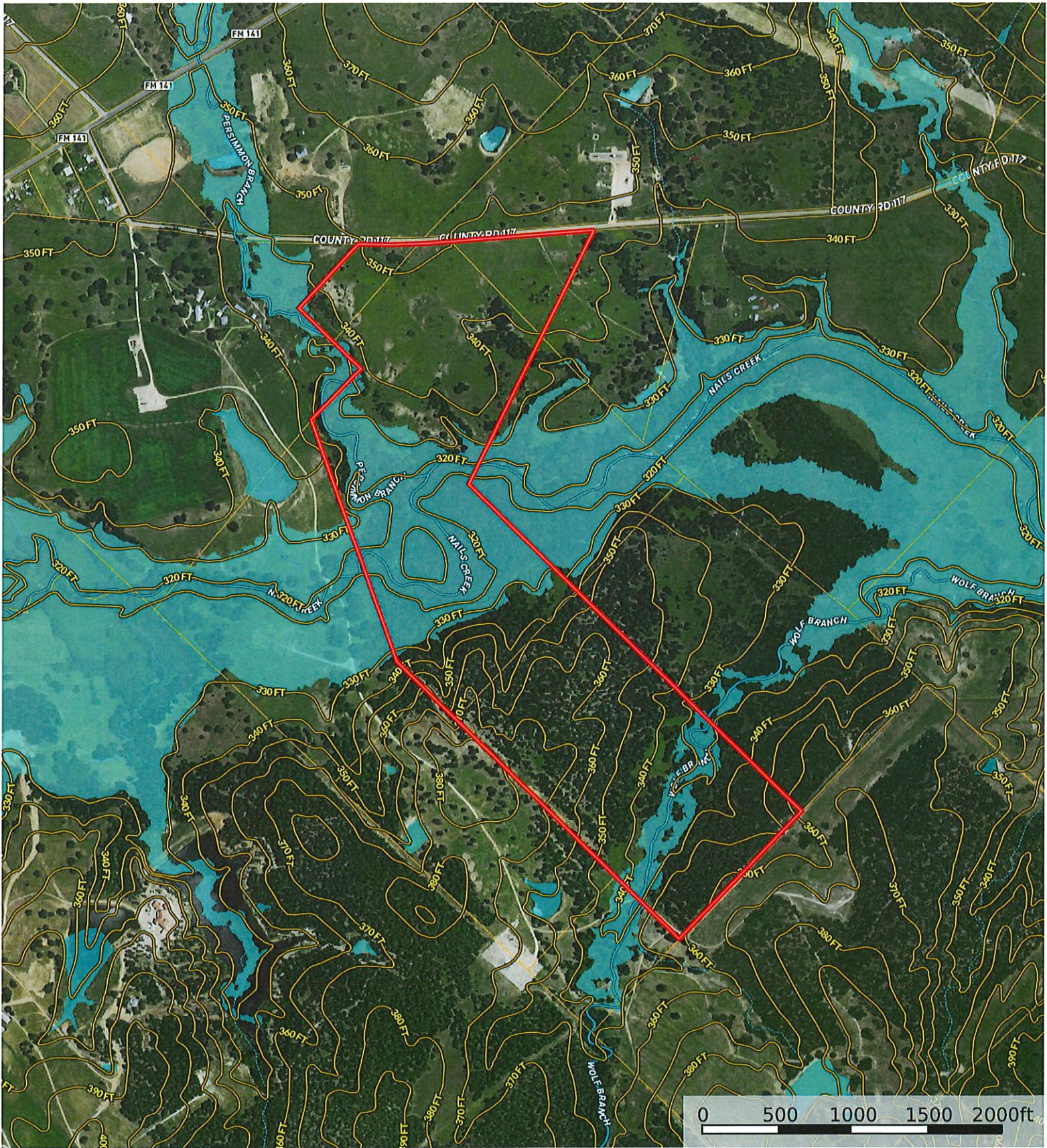
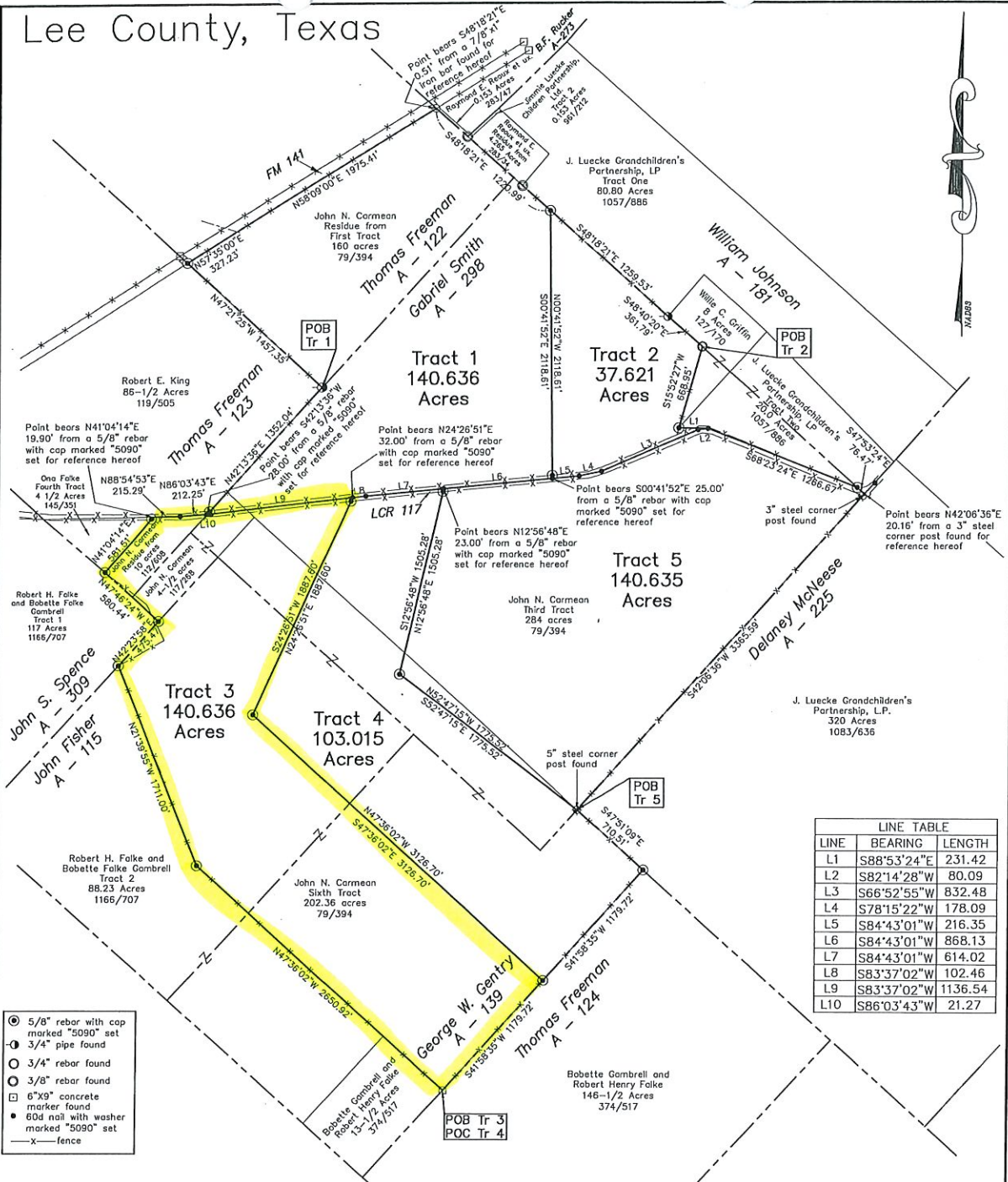

THENCE with the Northeast line of said 13-1/2 acre Gambrell tract, the Southerly Southwest line of said 202.36 acre Carmean Sixth Tract, **North 47 deg. 36 min. 02 sec. West** at approximately 635 feet pass a point for the East corner of an 88.23 acre Tract 2 described in a deed to Robert H. Falke and Bobette Falke Gambrell and recorded in volume 1166, page 707, the North corner of said 13-1/2 acre Gambrell tract, at approximately 2091 feet pass the Southeast line of said Fisher Survey, the Northwest line of said Gentry Survey, and continuing for a total distance of **2650.92 feet** to a 5/8 inch rebar with cap marked "5090" set for an interior corner of said 88.23 acre Falke Tract 2, an angle point of said 202.36 acre Carmean Sixth Tract, and an angle point hereof;

THENCE with the Southeast line of said Spence Survey, the Northwest line of said Fisher Survey, the Southeast line of said 117 acre Falke Tract 1, the Northwest line of said 202.36 acre Carmean Sixth Tract, **North 42 deg. 23 min. 58 sec. East - 475.47 feet** to a 5/8 inch rebar with cap marked "5090" set for the South corner of said 4-1/2 acre Carmean tract, the East corner of said 117 acre Falke Tract 1, and an interior corner hereof;

THENCE with the Northeast line of said 117 acre Falke Tract 1, the Southwest line of said 4-1/2 acre Carmean tract, **North 47 deg. 46 min. 24 sec. West** at 288.52 feet pass a point for the South corner of said Freeman Survey, A-123, an

interior corner of said Spence Survey, the South corner of said 10 acre Carmean tract, the West corner of said 4-1/2 acre Carmean tract, and continuing with the Southwest line of said Freeman Survey, A-123, the Southwest line of said 10 acre Carmean tract, for a total distance of **580.44 feet** to a 5/8 inch rebar with cap marked "5090" set for the South corner of a 4-1/2 acre Fourth Tract described in a deed to Ona Falke and recorded in volume 145, page 351, the West corner of said residue from said 10 acre Carmean tract and the Northerly West corner hereof;

THENCE with the Southeast line of said 4-1/2 acre Falke Fourth Tract, the Northwest line of said residue from said 10 acre Carmean tract, **North 41 deg. 04 min. 14 sec. East - 581.51 feet** to a point within the margins of Lee County Road 114, in the South line of an 86-1/2 acre tract described in a deed to Robert E. King and recorded in volume 119, page 505, for the Northeast corner of said 4-1/2 acre Falke Fourth Tract, the Northwest corner of said residue from said 10 acre Carmean tract, and the Northwest corner hereof; said point bears North 41 deg. 04 min. 14 sec. East - 19.90 feet from a 5/8 inch rebar with cap marked "5090" set for reference hereof;

THENCE within the margins of Lee County Road 117, with the South line of said 86-1/2 acre King tract, the North line of said residue from said 10 acre Carmean tract, **North 88 deg. 54 min. 53 sec. East - 215.29 feet** to a 60d nail with washer marked "5090" set, and **North 86 deg. 03 min. 43 sec. East - 212.25 feet** to a 60d nail with washer marked "5090" set in the Northwest line of said Smith Survey, the Southeast line of said Freeman Survey, A-123, the Northwest line of said 4-1/2 acre Carmean tract, for the Southeast corner of said 86-1/2 acre King tract, the Northeast corner of said residue from said 10 acre Carmean tract, the Southwest corner of a 140.636 acre Tract 1 this day surveyed, and an angle point hereof; said 60d nail set bears South 42 deg. 13 min. 36 sec. West - 28.00 feet from a 5/8 inch rebar with cap marked "5090" set in the North margin of Lee County Road 117 for reference hereof;

THENCE continuing within the margins of Lee County Road 117, across said 4-1/2 acre Carmean tract, with the South line of said 140.636 acre Tract 1 this day surveyed, **North 86 deg. 03 min. 43 sec. East - 21.27 feet** to a 60d nail with washer marked "5090" set, and **North 83 deg. 37 min. 02 sec. East** at 292.74 feet pass a point in the Southwest line of said 284 acre Carmean Third Tract, the Northeast line of said 4-1/2 acre Carmean tract, and continuing for a total distance of **1136.54 feet** to a 60d nail with washer marked "5090" set for the Northwest corner of a 103.015 acre Tract 4 this day surveyed, and the Northeast corner hereof; said 60d nail set bears North 24 deg. 26 min. 51 sec. East - 32.00 feet from a 5/8 inch rebar with cap marked "5090" set in the South margin of Lee County Road 117 for reference hereof;

THENCE across said 284 acre Carmean Third Tract, with the Northwest line of said 103.015 acre Tract 4 this day surveyed, **South 24 deg. 26 min. 51 sec. West** at 663.69 feet pass a point in the Northeast line of said 202.36 acre Carmean Sixth Tract, the Southwest line of said 284 acre Carmean Third Tract, at 1114.53 feet pass a point in the Northeast line of said Fisher Survey, the Southwest line of said Smith Survey, and continuing for a total distance of **1887.60 feet** to a 5/8 inch rebar with cap marked "5090" set for the West corner of said 103.015 acre Tract 4 this day surveyed, and an interior corner hereof;

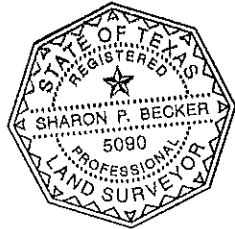
