


#### Abstract

METES AND BOUNDS DESCRIPTION OF A 5.005 ACRE TRACT OF LAND BEING ALL OF THAT CALLED 5.005 ACRE TRACT OF LAND DESCRIBED IN DEED TO LUPE L. JURADO RECORDED IN VOLUME 2701, PAGE 1510 OF THE OFFICIAL RECORDS OF FORT BEND COUNTY, TEXAS (O.R.F.B.C. ,TX) AND SITUATED IN THE GEORGE SCHLEY SURVEY, ABSTRACT NO. 391 IN FORT BEND COUNTY, TEXAS. SAID 5.005 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:


BEGINNING at a found $1 / 2$ inch iron pipe in the northwest line of a called 26.24 acre tract of land described in deed to Allen Wayne Dockal recorded in Instrument No. 2015048932 of the Official Public Records of Fort Bend County, Texas O.P.R.F.B.C.,TX marking the most easterly corner of said 5.005 acre tract and the most southerly southeast corner of a called 47.409 acre tract of land described in deed to Terrance Martin recorded in Instrument No. 9667321 O.P.R.F.B.C.,TX;

THENCE with the southeast line of said 5.005 acre tract and the northwest line of said 26.24 acre tract South 41 degrees 57 minutes 16 seconds West at 887.50 feet passing a set $5 / 8$ inch iron rod with cap stamped "RPLS 6229" in the northeast right of way line of Hand Road and continuing in all a total distance of 907.50 feet to a point with Hand Road marking the most southerly corner of said 5.005 acre tract and the most westerly corner of said 26.24 acre tract;

THENCE with the southwest line of said 5.005 acre tract North 48 degrees 09 minutes 01 seconds West 240.46 feet to a point marking the most westerly corner of said 5.005 acre tract and the most southerly corner of a called 5.00 acre tract of land described in deed to Michael Sanchez and Alicia F. Sanchez recorded in Instrument No. 2001010878 O.P.R.F.B.C., TX;

THENCE with the northwest line said 5.005 acre tract and the southeast line of said 5.00 acre tract North 41 degrees 58 minutes 58 seconds East at 20.00 feet passing a $1 / 2$ inch iron pipe found and continuing in all a total distance of $\mathbf{9 0 7 . 5 0}$ acre tract to a 6 inch wood post found in a southwest line of said 47.409 acre tract marking the most northerly corner of said 5.005 acre tract and the most easterly corner of said 5.00 acre tract;

THENCE with a southwest line of said 47.409 acre tract and the northeast line of said 5.005 acre tract South 48 degrees 09 minutes 01 seconds East 240.01 feet to the POINT OF BEGINNING of the herein described tract and containing 5.005 acres within these metes and bounds.
