Being more fully described by metes and bounds as follows:

- BEGINNING: at a 5/8" iron rod with cap, (Y = 13,730,631.86, X = 2,553,488.11), found at the southwest corner of an 11.70 acre tract conveyed to Deborah Bollom in Volume 581, Page 65 of the Official Records of Lavaca County, Texas, and in the north line of a 28.07 acre tract conveyed to Deborah Bollom in Volume 581, Page 65 of the Official Records of Lavaca County, Texas, for the southeast corner of this herein described tract;
- **THENCE:** S 88°21'59" W -774.82 feet along the north of said 28.07 acre tract and the south line of this herein described tract to a 5/8" iron rod with cap found at the northwest corner of said 28.07 acre tract and in the east line of a 42.11 acre tract conveyed to Aaron Lewallen in Volume 597, Page 515 of the Official Records of Lavaca County, Texas, for the southwest corner of this herein described tract;
