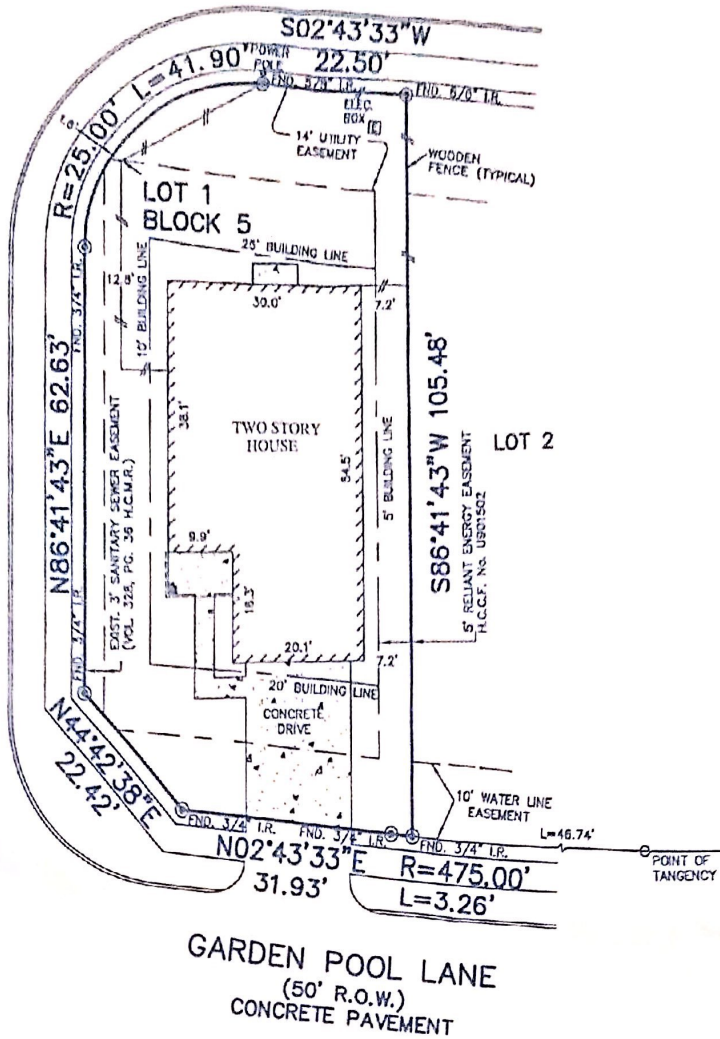


HUFSMITH - KOHRVILLE ROAD

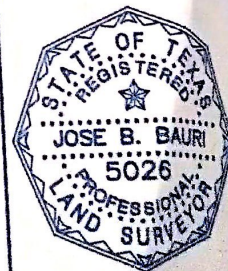
